**WHEREAS**, Russell Road is a county road and Pinal County Public Works Department has identified in a study that there is a need for improvements to Russell Road From Arica Rd to Selma Hwy, Township 7 South, Range 4 East, Sections 13, 14, 11, 12, 1, 2, and Russell Rd From Selma Hwy to SR84, Township 6 South, Range 4 East, Sections 34, 35, 26, 27, the "Project" and

**WHEREAS,** the State in agreement with the county has contracted for the design and construction of the project and to ensure all utilities are clear where relocation is not anticipated or required for the implementation of the Project to occur;

**WHEREAS,** the State in agreement with the county will need to contract for the construction of the project and provide for utility relocation and do all things necessary for the implementation of the Project;
