REGIONAL MASS COMMUNICATION SYSTEM

PINAL COUNTY, GILA COUNTY, GRAHAM COUNTY AND GREENLEE
COUNTY**

This Agreement is made and entered into by and among the signatory political subdivisions within the State of Arizona.

Recitals

WHEREAS, Pinal County entered into an Intergovernmental Agreement For the Establishment and Maintenance of a Regional Mass Communication System ("IGA") with Gila County ("Gila"), Graham County ("Graham") and Greenlee County ("Greenlee") jointly referred to as "Participating Parties"; and,

WHEREAS, the Paragraph 14 of the IGA provided that it had a one year term and could be renewed for three subsequent one year terms for a total potential term of four years; and,

WHEREAS, the Parties have previously exercised two extensions to the IGA; and

WHEREAS, The Participating Parties wish to exercise the third and final one year extension of the IGA;

NOW, THEREFORE, IT IS HEREBY AGREED by and between each and all of the signatories hereto as follows:

The Participating Parties who execute this extension hereby agree to a the third and final renewal of the IGA, as provided in Paragraph 14 of the IGA, for a period of one year from the anniversary date of the IGA. All other terms and conditions of the IGA shall remain the same.
