NOTICE is hereby given that the Board of Directors of Central Arizona Irrigation and Drainage District has called an Election to be held of the qualified electors of the District.

each Division.


The last date to file nomination petitions and papers at the District office is October 6, 2021. Voters may, at the election, write in a candidate's name other than the one name appearing for the Division only if that person has submitted to the District office no later than September 30, 2021 a Nomination Paper.

The acreage system of voting will be in effect for the election meaning that a person, in order to vote, must be 18 years of age or older and have owned real property in the District's taxable boundaries for over 90 days prior to the election if voting as an individual landowner. The ninety-day ownership requirement does not apply to lands owned by entities as set forth in State law.
