The Maricopa Family Advocacy Center provides a comprehensive, multi-disciplinary team approach to the investigation, prosecution and service provision to victims of child abuse and interpersonal violence. The center was established in 2019 by the City of Maricopa and has continuously served victims of crime in Pinal County. In July of 2021, the City of Maricopa entered into an Intergovernmental Agreement with Pinal County whereby the Pinal County Attorney's Office took over the leadership of the center. The Maricopa Family Advocacy Center now functions under the leadership of the Pinal County Attorney's Office, with an Advocacy Center Manager to manage daily operations and staff. The current manager, Melody Lenhardt has 20 years of experience working with victims and 17 years of leadership experience. The Mission Statement of the Pinal County Attorney's Office and the Family Advocacy Centers are as follows: Sworn to uphold the constitution, the Pinal County Attorney's Office (PCAO) is committed to using common sense and decency in the fair and impartial administration of justice. The Family Advocacy Centers function under the umbrella of PCAO. The Family Advocacy Centers protect and empower our most vulnerable by providing a victim-centered team approach to investigation and prosecution of crimes of personal violence while facilitating recovery and healing of crime victims. The Pinal County Attorney's Office Maricopa Family Advocacy Center (FAC) provides a comprehensive, multi-disciplinary team approach to the investigation, prosecution and service provision of victims of child abuse and interpersonal violence. This includes child physical abuse, sexual abuse and child neglect, child exposure to drugs and/or endangerment, human trafficking, crimes involving child witnesses (e.g. homicide, domestic violence and other violent crimes), adult sexual assault and domestic violence. When reports of child abuse are made to law enforcement or the Department of Child Safety (DCS), multi-disciplinary teams onsite at the FAC respond. The team consists of law enforcement, forensic interviewers, victim advocates, forensic nurses, mental health providers, prosecutors, volunteers and FAC administrative staff. Specialists such as DCS, OCWI or tribal social services personnel, respond based on the situation. The FAC offers a range of services based on the unique needs of victims (e.g. forensic interviews, medical forensic exams, victim advocacy, prosecutors). All FAC team members are trained in victim-centered approaches to the investigation and prosecution of violent "persons" crimes as well as evidence-based, trauma-informed methods of assisting victims. Services, with the exception of mental health, are offered onsite in a safe, comfortable setting in order to minimize possible secondary trauma from traveling to multiple sites of service, services repeated unnecessarily, or from service in less private settings. Mental health services are available through the center through a VOCA grant and are delivered virtually to victims and families in the comfort of their homes or a location of their choosing. Victim advocates provide referrals for other needed services outside the center. The multi-disciplinary team meets regularly to review and staff cases in order to constantly improve both investigations and services. The Pinal County Attorney's Family Advocacy Center staff participate in numerous community activities and work groups. Staff belong to the Pinal County Sexual and Domestic Violence Coalition, working closely to coordinate services and develop strategies and trainings to meet the needs of the community. The FAC also participates in the Pinal County Minor Victim Sex Trafficking Collaborative, a multi-agency collaborative effort to address trafficking in the community. The FAC manager regularly participates in meetings of the Pinal County Law Enforcement Association (PCLEA) to work closely with police chiefs and other community stakeholders to address community needs. The center is a member of the Arizona Child and Family Advocacy Center Network, with the Family Advocacy Center Manager participating in regular quarterly meetings and activities. Staff regularly participate in community events and fairs to provide community education, prevention and information. In addition, the FAC has hosted protocol trainings to partner agencies as well as co-sponsoring training in domestic violence for law enforcement in the past year.
