PINAL COUNTY Hand Count / Early Ballot Audit Report

March 17, 2020 Presidential Preference Election

Synopsis:

Pursuant to A.R.S. §16-602(B), Pinal County Elections Department conducted the hand count/early ballot audit for the March 17, 2020 Presidential Preference Election. Two (2) precincts were counted, as required by statute.

The hand count began on March 18, 2020, at 3:00 p.m. In lieu of representatives of the Pinal County Republican and Democratic Parties, which neither party designated by the deadline, the Early Board members were appointed to serve as Hand Count Board Members as well. This process was explained to the County Party Chairs and neither expressed any objections. The two Hand Count Boards were comprised of a mix of Democratic and Republican party members.

Tokens were created for each of the 51 polling places. Many of the polling places had multiple co-located precincts. All ballots were accounted for in the central counting location before the selection process started. Precincts 71/76/88 and 78/89 were selected by blindly pulling two labeled tokens out of a bowl. All ballots cast in these precincts were tabulated on ES&S DS850 optical scanning equipment.

For the early ballot audit, 1% of the early ballots were selected in 9 batches that contained an aggregate total of 453 ballots. As of March 5, 2020, an estimated 42,000 early ballots had been issued. To account for later-issued early ballots, the 1% estimate was 450.

The hand count was completed at 12:00 p.m. on March 19, 2020. There were zero (0) discrepancies between the machine count and the hand counts for both the early ballots and the polling place ballots. The aggregate precinct and early ballot reports are attached.
