



Special Event Sponsorship Agreement

This *Agreement* is between Pinal County, a political subdivision of the state (“*Sponsor*”) and the Dudleyville Community & Dudleyville Volunteer Fire Department (“*Dudleyville*”) (jointly referred to as “*Parties*”).

WHEREAS, Dudleyville is the host of the Dudleyville Light Parade and Fair; and

WHEREAS, the Dudleyville Light Parade and Fair is an annual civic event that brings in visitors from across the State and benefits the public by improving and enhancing the economic welfare of the residents of the area; and

WHEREAS, Pinal County is authorized to take actions and expend funds for economic development pursuant to A.R.S. §§ 11-254 and 11-254.04; and

WHEREAS, Pinal County wishes to sponsor the Dudleyville Light Parade and Fair subject to the terms and conditions set forth below.

NOW THEREFORE, The Parties agree as follows:

Sponsor agrees to waive the following permit fees as authorized by Section 2.151.040(B)(3)(j) of the Pinal County Development Services Code:

Pinal County Planning Division (TOTAL: \$10.00)

Dudleyville Permitting Obligation

Dudleyville shall timely submit a complete Special Event Application and applications for all other necessary County permits and approval, subject to the fee waiver described above. Dudleyville shall comply with all federal, state and local statutes, rules, regulations, ordinances, orders and permits in the conduct of the Dudleyville Light Parade and Fair.

Term of Agreement

The *Agreement* shall be in effect for the following period: Friday, December 8th, 2023 (8:00 AM – 10:00 PM), Saturday, December 9th, 2023 (8:00 AM-10:00 PM), and Sunday, December 10th (8:00 AM-12:00 PM)

Complete Agreement

This *Agreement* constitutes the only agreement, and supersedes all prior agreements and understandings -both written and oral- among the *Sponsor* and Dudleyville with respect to the subject matter hereof. This *Agreement* may not be amended or modified, except in writing with a signed and dated Amended Agreement by all parties.

Indemnification

To the fullest extent permitted by law, Dudleyville shall indemnify, defend, save, and hold harmless Sponsor, its agents, representatives, officers, directors, officials, and employees from and against any and all claims, demands, proceedings, suits, actions, losses, and damages of every kind and description, and expenses, including but not limited to attorneys’ fees, arbitration expenses, court costs, and the cost of appellate proceedings, which may be brought or made against or incurred by Sponsor on account of bodily injury, sickness, disease, death, or injury to, impairment or destruction of property, including losses of use resulting there-from caused in whole or in part, relating to, arising out of, or resulting from the negligent acts, professional errors, fault, mistakes, or negligent omissions, whether active or passive, of Dudleyville, or its employees, agents, representatives, its subcontractors and their employees, agents or representatives, and including any party for whose negligent acts, errors, mistakes, or negligent omissions Dudleyville may be legally liable in connection with or incident to the performance of this Agreement and arising out of Workers’ Compensation claims, unemployment disability compensation claims, or employees’ liability claims of Dudleyville’s employees and its subcontractors’ employees, and claims under similar such laws or obligations. To the fullest extent permitted by law, Dudleyville shall be responsible for its own negligent acts, omissions, and mistakes, and those of its employees, agents, sub-consultants, and subcontractors. Every obligation of this indemnification paragraph shall survive the completion of the services hereunder and the termination of this Agreement.
