Manes and Miracles Proposal Tohono O'odham Nation





A) As a single mother of four disabled, adopted children, Kara longed for her children to participate in physical therapy with equines but thought it was not within her means to afford. Evidence shows the far-reaching physical, mental, emotional, and cognitive benefits of using horses and other unconventional, yet highly effective outdoors-based tools as a part of therapeutic programs for individuals with disabilities. Unfortunately, the high cost of participation fees generally makes it out of reach for the children and families who benefit from it most, like Kara's. That is until the

establishment of the Manes and Miracles Scholarship Fund. Kara's children received full scholarships and she has been amazed at the progress they quickly achieved at the Ranch.

Kara's story is quite common. The burden of medical care expenses that families with

special needs children are saddled with is immense. We firmly believe that finances should not play a role in determining the best plan of care for a child. We seek to lift this burden by offering the life-altering healing that comes with equine-assisted therapy at little to no cost. After 6 years of successfully providing equine-assisted physical and occupational therapy for up to 70 children each week, we are now pleased to answer the demand for additional programs as we introduce adaptive riding, equine-assisted learning, and summer camps.



These new programs bring hope, happiness, and healing with horses to even more children with autism, down syndrome, PANDAS, ADD/ADHD, anxiety, and other physical and emotional disabilities. Through adaptive riding, higher-functioning children will build confidence as they learn horsemanship skills adapted to their unique abilities and goals. Equine-assisted learning teaches children vital life skills such as confident decision-making, communication, emotional regulation, positive social interactions, self-advocacy, responsibility for self and others, consideration, and more through their guided interactions with our horses and other ranch animals and environment.

Each session at Manes and Miracles bears an expense of \$285, a price that would be out of reach for our clients, 18.1% of whom are below the poverty level. While similar facilities in Arizona charge between \$30/session to \$200/session, we proudly offer

scholarships to *every* client, allowing clients to pay what they can afford with scholarships covering the remaining expense. During the 2022-2023 season, the Manes and Miracles Scholarship Fund provided \$110,580 in scholarship assistance for equine-assisted physical and occupational therapy alone. Inflation has seen expenses rise as much as 260%, making the Scholarship Fund more vital than ever. Our request for \$14,560 will provide one month of majority scholarships for 14 underprivileged children, like Kara's.

B) Manes and Miracles serves children between 3 and 18 years old with developmental disabilities in Pinal and East Maricopa counties. 67 children with physical, mental, and emotional disabilities receive deeply impactful services with us. 6% of our clients are Native American, 5% are black, 20% are Hispanic, 3% identify as multiracial, and the remaining 66% of clients are white. 32% of our clients are adopted or in foster care and 35% have a sibling or other family member also with a disability. We have around 140 children on our waitlist. Additionally, over 350 volunteer hours are



logged each week, many from individuals with disabilities themselves such as autism and PTSD. Individuals seeking to benefit from this proposal will apply for assistance based on their financial need and the recommendation of their supervising therapist ensuring that the funds are honored as disclosed in this application.

C) Manes and Miracles is requesting \$14,560 from the Tohono O'odham Nation's 12% Gaming Distribution for equine-assisted therapy and activities scholarships.

Direct program expenses represent 55% of the overall budget with most of the difference being staffing, fundraising, vehicles, bank fees, marketing, and other organizational overhead expenses.
Budgeted program fee income	\$33,300	Income from program fees, budgeting \$12,000 from equine-assisted therapy, \$11,000 from equine-assisted learning, \$6,600 from adaptive riding, and \$3,700 for summer camps.
Total Scholarship Budget	\$178,004	Total program expenses, less income from program fees, leaving the budget necessary for the Scholarship Fund.
Tohono O'odham Grant	\$14,560	One month (4 sessions) of majority scholarships for 14 children with special needs to participate in equine-assisted activities and therapies. (\$260/session x 14 children x 4 sessions)
Other Grants	\$65,000	Grants identified in section D as well as several others identified and will be applied for within the 2024 fiscal year.
Private Donations	\$57,500	Donations requested to be applied to the scholarship fund.
Fundraisers	\$40,944	Fundraising dollars to cover any deficiency in the scholarship budget.
Total Scholarship Funding	\$178,004	

- D) To sustain our Scholarship Fund, we partner with community leaders whose values align with ours including but not limited to, the following:
 - Donald C Brace Foundation, \$20,000 grant, funded.
 - The Giving Machines, \$22,700 grant, funded.
 - Ak-Chin Indian Community, \$14,000 grant, funded last season with some budget remaining for the 2024-2025 season. An additional \$14,000 grant application for the current season is under review.
 - Walmart, \$15,000 grant, funded with \$3,000 earmarked for scholarships.
 - Walmart, \$70,000 grant, under review.
 - Gila River Indian Community, \$14,000 grant, under review
 - Private Donor, \$7,500, under review.
 - Additional grants and fundraisers will be submitted.
- E) We have not previously received a grant as part of the 12% distribution from the Tohono O'odham Nation. We received \$14,000 from the Ak-Chin Indian Community on March 1, 2024 as a part of the 2023 Tribal Gaming Grant.
