
Amount being requested: \$108,000

Project summary: Horizon proposes to renovate a current vacant property in Apache Junction into a community room that will offer both educational and recreational activities to people suffering from a mental health and/or substance use issue. Services will include educational classes on employment skills, living skills, medication educations and resource availability and assistance in obtaining various resources. Recreational activities will include social skills building with coffee talks, reading clubs and various outings.

Beneficiaries: This project will serve individuals suffering from mental health and/or substance use issues as well as the homeless population in Apache Junction.

Tohono O'odham Proposal for 12% Gaming Distribution

Project: Horizon Health and Wellness

a) Explain the perceived need and explain how the proposal will address that need:

Horizon Health and Wellness (HHW) is a non-profit 501(c)(3) integrated health care agency licensed by the State of Arizona and accredited through the Joint Commission to deliver an extensive array of healthcare services for all ages and stages of life. The community of Apache Junction is a rural area with limited resources specifically for those that suffer from a mental illness or substance use disorder. HHW is able to provide treatment and recovery services for this population, however a big part of the recovery process is the ability to engage in educational and social activities. Currently Apache Junction does not have a safe place for this to occur. HHW is proposing to complete repairs and modifications to a vacant property that is owned by HHW in Apache Junction to create this safe space for community social/recreational activities. The remodeling of this property will allow HHW to provide a space in Apache Junction for those that have a substance use issue or mental health issue to come in and meet others who also struggle with the same issues. Classes and activities will center around health education, employment/educational skills building and social/recreational activities all while creating a space for individuals to decrease their social isolation and build friendships with others that have common interests. This space will provide the community with a place to build social support for many of the individuals that lack informal support all in a space specifically designed for them. The design will include many components of trauma informed care environment since this population typically comes from a background which includes trauma. Items such as muted and calm paint colors, lights that dim, and quiet spaces will all contribute to healing and recovery of this extremely vulnerable population.

b) Describe the population who will benefit from the proposal if approved:

This project will benefit the community of Apache Junction and the surrounding area by offering a space for individuals with mental illness and substance use issues to gather and find not only resources but support from others. Individuals with substance use and mental health are often socially isolated from others which cause depression, anxiety and often can lead to relapse or even suicide. In addition, there is a high rate of homelessness in this population and even if they are sheltered during the night most shelters do not allow daytime stays. This center would provide a safe and secure place for daytime activities and get these people off the streets during the day.
