Three Precious Miracles Displaced Native Youth Cultural Program

Needs Statement

Three Precious Miracles is a Native-led 501(c)(3) non-profit organization founded in 2014 to support the families of Native American children who are displaced so they can provide a loving, caring, and culturally sensitive home.

As part of our mission, we partner with an Arizona rehabilitation center (due to privacy reasons of the minors, we are unable to name the facility) to meet and support their Native American youth residents. Three Precious Miracles provides a cultural connection to complement contemporary medicine as part of their healing through this partnership. Our team conducts a two-hour, twice-monthly program utilizing traditional Native American practices - such as a drum circle, smudging ceremony, traditional songs, and more - to help develop a healthy cultural and self-identity while in the facility and beyond. Included on our team is a facilitator that rotates throughout the year to help bring additional perspectives, insights, and cultural expertise to the youth.

The development of our Native American youth is extremely important to their overall identity as Native Americans. Traditionally, identity takes place in a cultural context and is established through observation and nurturing by elders and family members within a Tribal community which is why our partnership is so valuable for these youth. Since this particular population most likely does not have immediate access to these resources, Three Precious Miracles prioritizes bringing culture to the facility.

Since the program's start, we have established positive relationships with the youth through our teachings. As our team enters the facility, they are greeted with excitement and have been honored with the moniker "Auntie", a sign of respect, cultural identity progress, and the building of trust. We are making a difference in their lives.

We are requesting support from the Tohono O'odham Nation to continue this important work and to help expand into the additional traditional practices of sewing ribbon skirts, creating medicine bags, crafting gourd rattles, and beadwork that are part of developing identity and creating healing but require more cost. We are requesting support for the supplies, travel to and from the facility, refreshments to help engage the youth, and costs to help bring in a cultural facilitator each visit.

Population

The Native American youth residents of the rehabilitation center will benefit from this funding, as they learn to use their cultural connection to heal and build a healthy self-identity. The youth are ages 10-17 and in the facility for a variety of reasons, like suicide attempts, lack of foster homes, and runaways. The amount of youth that

participate in the programs varies based on their circumstances for being in the facility; and, unfortunately, there is an on-going need for this population because as youth leave, there will be more that take their place.

Budget

Three Precious Miracles is requesting \$24,808 in funds to support one year of programs. We have provided a budget detail table and budget narrative below to outline how the funds will be used.

Budget Narrative

• Facilitator: \$6,000

Cost of facilitator for two hours per program at two programs per month, totaling four hours per month. Responsibilities include facilitating conversation and connecting the cultural activities with the facility's treatment plan.

• Refreshments: \$1,200

Cost of water and a healthy snack for participants at each program. Providing refreshments helps bring a sense of community as we eat together as a group.

• Mileage: \$1,608

IRS mileage rate of .67 for our staff to travel 100 miles roundtrip per program.

• Activity Kits: \$15,000

Cost of activity kits for the ribbon skirts, medicine bags, gourd rattles, and beadwork. These items were chosen as they contribute to developing a cultural and self-identity, and support healing. Each kit costs between \$25-\$100 and the quantity of each kit and amount needed per program will depend on the youth at the facility at the time of the activity.

Miscellaneous Supplies: \$1,000

Cost to cover sage, drums, and additional craft and paper supplies such as scissors, markers, and poster board.

Other Funding Requests

Three Precious Miracles has graciously received an annual contract from the Arizona Department of Child Safety. The \$24,000 in funds support child abuse awareness programming in Apache and Pinal Counties. We are constantly looking to build out our lines of revenue to help sustain the activities that we perform year in and year out.

Previous 12% Distribution

Three Precious Miracles has not received funding from Tohono O'odham Nation or other Arizona Tribes.

ADDENDUM
