RE: Tohono O'odham Nation's Request for Proposal for the Arizona Revised Statute 5-601-02 12% Gaming Distribution

Begin Again Homes, Inc. (BAH) is a non-profit 501(c)3 organization serving Apache Junction, Arizona. BAH was started by a small group of concerned citizens, each of whom are business owners, in Apache Junction, and who had independently developed a strong desire to help the growing number of homeless individuals and families in the city.

BAH aims to provide stable, safe and private housing at no-cost for a period not more than one calendar year, to members of the community who are currently homeless due to economic distress. Apache Junction does not have an emergency shelter available, section 8 housing continues to maintain a three to five year waiting period, and affordable housing is scarce. BAH provides medium term support to bridge the gap between the time a person loses shelter and the time at which they can establish a new home, thus halting what is commonly a rapid decline towards various other forms of unnecessary hardship.

The perceived need is the lack of a temporary emergency shelter in Apache Junction. An Emergency Shelter will provide a safe place to stay as well as the fill-in gap for people with approved housing vouchers who are waiting for final inspection on their permanent housing. This will help them achieve their goals of self-sufficiency. BAH will also help to reduce the strain on non-local emergency shelters. There is not currently any sort of shelter for the homeless members of our community in Apache Junction.

According to the 2023 Point In Time (PIT) count in Apache Junction, 91 homeless people participated. These individuals consisted of families, veterans, seniors, and disabled individuals. This is the population we are looking to serve with emergency shelter.

When no immediate shelter is available through BAH or other housing resources, BAH will pay for hotel stays for interims not to exceed one month, provided that certain criteria are met by the client.

BAH is proposing an emergency shelter utilizing temporary hotel stays at Motel 6 in Apache Junction. Eligibility criteria includes, but is not limited to, being homeless or at risk of homelessness, having a demonstrated need for supportive services, be willing to work with case managers to achieve the clients goals, have a verified housing voucher, be in the process of obtaining permanent housing and prove they are not currently battling any mental health or substance abuse issues. This will allow families and individuals with a safe place to stay and temporary housing. This will serve as the fill-in gap for people with approved housing vouchers who are waiting to achieve permanent housing including final inspections. These individuals will be able to gain access to further supportive services, employment opportunities and build a support network during this gap period.

BAH operated such emergency shelter throughout June-December 2023. During this time period, we resourced 23 people, provided a total of five (5) emergency shelter stays, and assisted in obtaining permanent housing for these five (5) individuals. The use of Motel 6 as the temporary emergency shelter was made possible through various donations from local businesses and community members.

If approved, the population who will benefit from this proposal are the homeless community in Apache Junction, AZ. This population will consist of seniors, families, individuals and veterans of the general public. This project is expected to have a significant impact on the homeless population in the city, and it will help to reduce the strain on emergency services.

The total project budget is \$20,000.00. The funding will be used to cover the motel fees through December 31, 2024 or longer depending on how many people utilize emergency shelter and the length of time such shelter is needed.

There have not been any other funding requests made for temporary emergency shelter for 2024.

Begin Again Homes, Inc. has not previously received a 12% distribution from the Tohono O'odham Nation or other Arizona tribes
