A RESOLUTION OF THE PINAL COUNTY, ARIZONA, BOARD OF SUPERVISORS AUTHORIZING ACQUISITION OF RIGHT OF WAY FOR A PORTION OF ROAD KNOWN AS N. ROCKCLIFFE BLVD LOCATED IN SECTION 27, TOWNSHIP 9 SOUTH, RANGE 15 EAST.

WHEREAS, previous land divisions left a strip of property which is currently used by the public as a road known as N. Rockcliffe Blvd; however, the right of way was not dedicated to the County; and

WHEREAS, the Pinal County Engineer recommends the establishment of N. Rockcliffe Blvd as a County Highway and maintenance of that certain roadway known as N. Rockcliffe Blvd, located in Section 27, Township 9 South, Range 15 East, for the use and benefit of the public, more specifically depicted in attached Exhibit A; and

WHEREAS, the Board of the Pinal County, finds it necessary and in the public interest to acquire property for the establishment and maintenance of the public roadway known as N. Rockcliffe Blvd.

NOW THEREFORE, the Board of Pinal County hereby solves that:

The Pinal County Public Works Department and the Pinal County Attorneys' Office are hereby authorized and directed to acquire the real property and/or real property interest, including the use of Eminent Domain, in the property described in Exhibit A attached hereto, in Section 27, Township 5 South, Range 6 East for the establishment and maintenance of N. Rockcliffe Blvd.

BE IT FURTHER RESOLVED, that this Resolution shall become effective upon recording of said Resolution with the Office of the County Recorder, Pinal County, Arizona.

## LEGAL DESCRIPTION

A STRIP OF LAND AS SHOWN ON RECORD OF SURVEY, MINOR LAND DIVISION FEE NUMBER 1998-047190 RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF PINAL COUNTY, ARIZONA DATED NOVEMBER 17<sup>TH</sup>, 1998 AND LOCATED IN SECTION 27, TOWNSHIP 9 SOUTH, RANGE 15 EAST OF THE GILA AND SALT RIVER MERIDIAN, PINAL COUNTY, ARIZONA. SAID STRIP MORE PARTICULARLY DESCRIBED AS FOLLOWS:

**COMMENCING** AT THE EAST QUARTER CORNER OF SECTION 27, TOWNSHIP 9 SOUTH, RANGE 15 EAST OF THE GILA AND SALT RIVER MERIDIAN, PINAL COUNTY, ARIZONA;

**THENCE** ALONG THE EAST LINE OF SAID SECTION 27, SOUTH 00 DEGREES 28 MINUTES 38 SECONDS WEST, A DISTANCE OF 122.03 FEET TO INTERSECTION WITH THE SOUTH RIGHT OF WAY LINE OF STATE HIGHWAY 77 AS SHOWN ON ARIZONA STATE HIGHWAY DEPARTMENT RIGHT OF WAY PLAN OF THE TUCSON-ORACLE JCT.-GLOBE STATE HIGHWAY, PROJECT NUMBER F-031-1-809, SHEET 14 DATED SEPTEMBER 28, 1972;

**THENCE** ALONG SAID SOUTH RIGHT OF WAY LINE, SOUTH 87 DEGREES 53 MINUTES 55 SECONDS WEST A DISTANCE OF 10.10 FEET TO THE BEGINNING OF A TANGENT CURVE CONCAVE SOUTHERLY AND HAVING A RADIUS OF 11359.16 FEET;

**THENCE** ALONG SAID CURVE TO THE SOUTHWEST, THROUGH A CENTRAL ANGLE OF 06 DEGREES 47 MINUTES 50 SECONDS A DISTANCE OF 1347.56 FEET TO THE **POINT OF BEGINNING** OF THIS DESCRIPTION;

**THENCE** CONTINUING ALONG SAID CURVE TO THE SOUTHWEST THROUGH A CENTRAL ANGLE OF 00 DEGREES 18 MINUTES 25 SECONDS A DISTANCE OF 60.88 FEET;

**THENCE** LEAVING SAID RIGHT OF WAY, SOUTH 00 DEGREES 34 MINUTES 33 SECONDS WEST A DISTANCE OF 876.88 TO THE INTERSECTION WITH THE NORTH RIGHT OF WAY LINE OF AMERICAN AVENUE (FORMERLY KNOWN AS "OLD" STATE ROUTE 77) AS SHOWN ON ARIZONA STATE HIGHWAY DEPARTMENT STRIP MAP OF THE ORACLE JCT.-ORACLE HIGHWAY, PROJECT NUMBER S-253, DATED MARCH 1940 SAID INTERSECTION ALSO BEING A POINT ON A NON-TANGENT CURVE CONCAVE SOUTHERLY THE RADIUS POINT OF WHICH BEARS SOUTH 10 DEGREES 03 MINUTES 37 SECONDS WEST AT A DISTANCE OF 11509.40 FEET

**THENCE** ALONG SAID CURVE TO THE SOUTHEAST THROUGH A CENTRAL ANGLE OF 00 DEGREES 18 MINUTES 11 SECONDS A DISTANCE OF 60.86 FEET;

**THENCE** LEAVING SAID AMERICAN AVENUE RIGHT OF WAY, NORTH 00 DEGREES 34 MINUTES 33 SECONDS EAST A DISTANCE OF 897.24 FEET TO THE INTERSECTION WITH SAID STATE HIGHWAY 77 RIGHT OF WAY AND THE **POINT OF BEGINNING** OF THIS DESCRIPTION.
