**RESOLUTION OF THE PINAL COUNTY, ARIZONA, BOARD OF SUPERVISORS
SCHEDULING AN AUCTION FOR THE SALE OF REAL AND PERSONAL

WHEREAS, A.R.S. § 11-251(9) authorizes the Board of Supervisors to sell real and personal property owned by the County at auction; and

WHEREAS, The County holds title to the real and personal property listed in **Exhibit “A”** attached hereto and appraisals have been performed on the real property parcels; and

WHEREAS, The Pinal County Board of Supervisors has determined that it would be in the County’s best interest to sell the properties listed in Exhibit “A” if the minimum sales price is met; and

THEREFORE, BE IT RESOLVED, the Pinal County Board of Supervisors shall hold a public auction of the properties listed in Exhibit “A” on Wednesday, September 11, 2024 at 10:00 am in the Ironwood Room of the Historic Pinal County Courthouse at 135 N. Pinal Street, Florence Arizona.

BE IT FURTHER RESOLVED that the terms of the auction are as set forth in **Exhibit “B”** attached hereto and no bids shall be accepted that are not in compliance with the established terms. Properties will be sold as is with no recourse to the highest bidder meeting or exceeding the minimum bid amount.
