Apache Junction Unified School District's has been serving Apache Junction and Gold Canyon Communities since 1952. Apache Junction Unified School District's mission is to provide a world-class education that empowers students from kindergarten through 12th grade to become innovative scholars, college/career prepared, and compassionate global citizens. We are committed to fostering a dynamic learning community that cultivates intellectual curiosity, critical thinking, and a passion for lifelong learning.

The impacted amenities while owned by the Apache Junction Unified School district, are available for the broader Gold Canyon Community to enjoy. Pinal County Open Space, Trails & Regional Parks provides several neighborhood/community parks to support outdoor leisure and recreation for residents of all ages. However, there are no public Pickleball Courts in Gold Canyon despite being named the fastest growing sport in the US for several years. Pickleball is a multi generational sport bringing together communities in a way that supports both physical and mental well being which is aligned to Pinal County Open Space, Trails & Regional Parks objectives. Pinal County Open Space, Trails & Regional Parks will not have an active role in the execution of this project given the land is owned by the Apache Junction Unified School district, however, Pinal County residents will directly benefit from this project.

3. Describe the proposed project, objectives, and your plan to implement.



The school and community pickleball courts are currently makeshift courts superimposed on an existing cement basketball courts. The objective of the project is to surface the courts with standard pickleball surfacing and provide durable portable nets so the courts can be used for both pickleball and basketball by both the school and the community.

To implement this, standard court surfacing would be applied to the cement with lines painted to support 3 Pickleball courts in addition to the 2 existing basketball courts. Durable nets would be purchased and landscaping surrounding the court would be enhanced to protect the new surface in order to ensure its longevity.

4. Describe how the proposed project satisfies one or more of the priority funding areas identified by the Gila River Indian Community.

This project directly supports the GRIC funding area of Healthcare. Pickleball growth is rapidly growing within our community schools and surrounding neighborhoods. It promotes health in many important ways including physical fitness and mental health. The Gold Canyon school and community is lacking public pickleball courts to meet this growing demend – this project will support the overall health and well being of our students and community.

5. Identify the needs/problems to be addressed, the target population and number of people to be served by the project.

The need to be addressed is to provide Pickleball courts for the school and the community in order to provide facilities for this fast growing, multi-generaltional sport which provides physical activity in a fun and social manner resulting in a positive mental impact and community building for participants. The target population is the students of the Peralta Trails Elementary School (approximately 300 students) as well as the broader Gold Canyon Community of Pinal County (approximately 13,500 residents).

6. Define the project as a new or continuing program. Has GRIC previously funded this project?

This is a new Project which has not been previously funded by GRIC.

The overall project can be completed in 3 months. The timeline would commence with 1-2 of weeks of landscaping prep, followed by 3 weeks for the cement prep and court surfacing and lastly with the delivery of the nets. The timeline is flexible.

  - The Peralta Trails Pickleball club is partnering with the Peralta Trails Elementary school and the Apache Junction Unified School district to oversee the overall project.
- 9. Would you be able to implement the proposed plan if your organization received partial funding for this project?
  It depends on the funding received. At a minimum, the school district would require \$13,500 to complete the sufacing project.
- 10. Describe your plan for project financial sustainability beyond the grant period. If this is a program/project previously funded by the Gila River Indian Community, describe efforts made towards the previously described sustainability plan.
  - The court surfacing is expected to have a minimum court life of 5 years. The life of the court would be extended by the included landscaping work to prevent rocks and debris being blown onto the court and scratching the surface. In addition, the semi-permanent nets included in the project are designed to be able to be moved without damaging the court surface. If the court needs repair in the future, the school would seek grants or donations from the community to fund the repairs.

  - A project manager will be assigned to oversee the overall project. Regular project timeline and progress updates and budget tracking will be provided as required by GRIC and the Pinal County Sponsor.

- 1. Contrete Repair and Patchwork. This cost is \$750. The purpose of this cost is to prepare the current cement surface to fill cracks and repair any irregularities prior to applying the court surfacing. This estimate was provided by Just Pickle Courts (justpicklecourts.com) this is a vendor who specialized in court surfacing.
- 2. Acrylic Surfacing with Pickleball court lines. This cost is \$12,500. The purpose of this cost is to apply the Acrylic court surfacing including painting the court surface and adding the lines for the 3 pickleball courts. This estimate was provided by Just Pickle Courts (justpicklecourts.com) this is a vendor who specialized in court surfacing.
- 3. Paint Basketball lines. This cost is \$750. The purpose of this cost is to re-apply the current basketball lines as the Acrylic surfacing will cover the existing lines. This is needed in order to maintain the existing basketball function of the courts as this will be a multi-purpose court supporting both basketball and pickleball. This estimate was provided by Just Pickle Courts (justpicklecourts.com) this is a vendor who specialized in court surfacing.
- 4. 3 Rolling Nets. This cost is \$6000 (\$2000 per net). The puropose of this cost is to supply moveable nets which can be rolled onto the pickleball courts during play and removed after pickleball play in order to retain the basketball function of the courts. This estimate was provided by Just Pickle Courts (justpicklecourts.com) this is a vendor who specialized in court surfacing.
- 5. Rocks 4 tons delivered and placed. This cost is \$860. The purpose of this cost is to cover the gravel perimeter of the court wit half inch rock in order to prevent sand and rocks from blowing onto the court and damaging the newly applied court surfacing. The rock cost and delivery cost estimates are from AZ Rock Express (azrockexpress.com)
- 6. Liquid Rock Binder this cost is \$504. The purpose of this cost is to apply binder to the gravel perimeter to prevent placed rock from blowing onto the court and damanging the court surface. The cost estimate is from Amazon.
- 7. Contingency this cost is \$1,043. The purpose of this budget entry is to include a 5% contingency to cover potential price changes between initial quotes and project execution and to mitigate any other potential risks or unforeseen challenges which may arise.
