1. Briefly describe your organization's history, mission and goals.

Maricopa Pantry has served Maricopa and its surrounding communities, including rural areas, for 12 years.

Our mission is "Neighbors Helping Neighbors". Our food distributions are weekly and provide food to 1700 – 2000 families every week. We also provide other community services through partnerships with organizations that supply Alcoholics Anonymous, free legal advice, housing/insurance counseling, and more. Our goals include providing the facilities needed for more services that have been requested: drug counseling and programs, veteran's services, healthcare services, and healthy meals programs, among others.

While not in partnership with any government service, we align with county programs that promote individual, family, and community health, well-being, and self-sufficiency. Our distributions provide healthy food, while emergency supplies are kept available for District and County law enforcement, victim's advocates, and fire fighting services. Some families depend heavily on our food while others use the food to stretch their income dollars to cover other costs.

We provide some community programs help individuals overcome addictions and provide needed advice. Planned future programs include providing health monitoring and counseling, resume building and job hunting, services for veterans, and more - all geared toward building healthy and self-sufficient families. This builds stronger communities, lowering the need for government intervention in the health and welfare of their constituents.



3. Describe the proposed project, objectives, and your plan to implement.

The proposed project is the second building in our complex. It will be two-story, 40' x 60', with open space for meetings as well as smaller conference rooms. We hope to have permits in place by spring 2026, with the objective of groundbreaking in the summer of 2026. Our Project Manager is implementing the timeline by beginning the permit process with Pinal County Planning, even as we erect and finish Phase 1, which is the warehouse. Contractors are submitting proposals. We desperately need the space, storage, and efficiency that both of these buildings will give us.

4. Describe how the proposed project satisfies one or more of the priority funding areas identified by the Gila River Indian Community.

Most of the food we distribute consists of fresh vegetables, fruits, and shelf-stable food. Fresh produce is pricey, and many families choose between purchasing proteins or produce because of the price of buying both. Shelf-stable foods are staple items that ensure full meals even when funds are short. Supplying both helps ensure families can make healthy and nutritious meals. Extra storage will allow us to store more emergency supplies, like water, allowing us to benefit community and county services even more in times of crisis.

The community center will diversify the other services we can offer, helping to treat their emotional and spiritual needs. We will be able to provide programs that provide concrete skills and basic needs, thus promoting healthier and more self-sufficient families.

5. Identify the needs/problems to be addressed, the target population and number of people to be served by the project.

Residential needs are many. They are largely rural or country properties, not close to town. Many are low income. They need help with legal services, medical services, and counseling that we can provide. We have professionals ready to teach skills in preparing resumes, job-hunting, and navigating interviews. We have businesses willing to begin apprenticeship and training programs. We have documented treatment programs for drug and alcohol abuse. The church, which will also use the building, is ready to help with spiritual needs. The target population is anyone who can benefit. Some specific populations include veterans, teens/young adults, those fighting addictions, and low income. We also serve a population of homeless and migrant workers.



Because the services to be offered will be staggered and varied, and all such services are voluntary, it is impossible to gauge the number we can serve. Currently our building only holds 60 people. The Phase 2 building will hold nearly 300. We will be able to house many more at a time, and many different programs as well.

6. Define the project as a new or continuing program. Has GRIC previously funded this project?

This is a continuing program building a new and permanent home. GRIC has not previously funded any part of this project.

7. Provide a brief timeline including start and finish dates. Indicate if the timeline is flexible.

We hope to have permits by spring 2026 and beginning building in summer of 2026. Building should be operational soon thereafter. This timeline is very flexible, depending entirely upon two things: the energy shown by Pinal County Planning, and available funds.

8. Identify other organizations, partners or funders participating in the project and their roles.

Mountain View Community Church (MVCC) shares the property, the vision, and the workload. They currently hold funds of approximately \$150,000 toward this project. McS Charitable Foundation of Scottsdale, AZ is a partner foundation. They have donated substantially toward Phase 1, donate quarterly for operating expenses, and have promised recurring support. The Ak-Chin Indian Community support us with grants and gifts, and promotion. Harrah's Casino and Ak-Chin Circle support us with sponsorships and fundraisers. Home Depot, Exceptional Health, Banner Health, MUSD School system, and many local businesses and organizations support us with fundraisers and sponsorships. Pinal County BOS has donated to Phase 1, and I believe will also donate to Phase 2. In addition, we are an Arizona Charitable Tax Donation and receive donations that way.

9. Would you be able to implement the proposed plan if your organization received partial funding for this project?

We will implement Phase 2 regardless of the support received by this grant. However, any portion of the requested grant brings us to the goal more quickly.



10. Describe your plan for project financial sustainability beyond the grant period. If this is a program/project previously funded by the Gila River Indian Community, describe efforts made towards the previously described sustainability plan.

Building all phases of the Church Complex is the expensive part. Aside from funds toward the Complex, we receive enough donated funds to cover our overhead and see no reason that will change. We enjoy amazing support from local businesses, organizations, and individuals who believe in our mission and our work. In addition, we have several foundations and grant programs who support us regularly, like McS, Frontstream, Maricopa Lion's Club, and Shiloh Church of Maricopa. MVCC is also prepared to provide additional operating funds for expenses we have not experienced yet, like the added cost of electricity.

Maricopa Pantry conducts quarterly meetings and progress is documented. Meeting minutes will be available. In addition, the vice-president is prepared to provide progress reports as needed.
