1. Briefly describe your organization's history, mission and goals.

The Arizona City Moose Lodge Family Center #1038 began operating in 1972. The Loyal Order of Moose is an international organization of men and women dedicated to caring for young and old, bringing communities closer together, and celebrating life. The mission of our organization is to strive for excellence in community service, provide for our children in need, and provide for the needs of our seniors. We successfully continued meeting these ideals until August of 2020 when our lodge tragically was completely destroyed by fire. Although woefully underinsured at the time of loss, we have worked diligently towards getting our lodge and community center operating again. We now have a new building that we are working on finishing. However, due to expenses we are currently unable to finish the kitchen area. Our goal is to finish the kitchen to start serving meals in our community again.

Our lodge is designated as a family center. As such we will provide a place for the community to gather for many different functions. We will have a full-service social quarters area with pool tables, electric dart machines, and available music for entertainment. We will also have community bingo nights. In the past we have funded and awarded \$1000 scholarships to 2 local high school seniors, and we have also contributed funding for the Arizona City Boy's and Girl's Club, provided a Christmas and an Easter party for local children, supported the Valley Humane Society, supported the local Citizens on Patrol, participated in the clean-up efforts along Sunland Gin Road coming into Arizona City, provided volunteers and financial support for Arizona City Fire District's Summer Water and Safety Days for children, and we plan on continuing these projects for our community. If we can finish the kitchen then we can also offer weekly meals to our local community.

3. Describe the proposed project, objectives, and your plan to implement.

Our proposed project is to remodel the storage area into a completely functioning kitchen to prepare and serve meals to our community customers and to provide a venue that also has a full kitchen for community members to rent for functions. With the completion of the kitchen, we will also need to install a fire suppression system throughout the



building to meet state and local fire codes. All major work needed to comply with building codes will be done by licensed contractors. To remodel the storage area into a complete kitchen we will:

- If necessary, reconstruct exiting walls to accommodate new kitchen equipment
- Install new kitchen equipment
  - 6 burner gas stove
  - o 2 Gas Deep-Fryers
  - o Bakery oven
  - o Commercial Microwave
  - o High temperature dishwasher
  - o 3 Compartment Stainless Steel Commercial Sink
  - Stainless steel prep table
  - Stainless steel wall cabinets
  - Stainless steel base cabinets
  - o Walk-in cooler
  - o Walk-in freezer
  - Install an Ansul fire suppression system in kitchen
  - o Install a new sprinkler system throughout building to meet fire/building requirements
  - New signage to provide information to the community

#### The Moose Family Center:

- Provides a gathering place for community members
- Provides Christmas and Easter parties for community children
- Donates funding for AZ Fire District's Summer Water and Safety Days for community children

- Helps provide volunteers for Citizens on Patrol
- Provides volunteers for Sunland Gin Road clean-up
- Collects needed supplies for local students
- Helps provide funding and support for Humane Society through donations

The Moose Family Center #1038 has approximately 250 members and Arizona City has a population of approximately 13,000. Our Family Center can provide a gathering place for socializing in the community that Arizona City currently lacks. The lodge will be open daily with weekly bingo and other community functions.

6. Define the project as a new or continuing program. Has GRIC previously funded this project?

This project is a new project. GRIC has never funded any project for AZ City Moose Family Center #1038.

7. Provide a brief timeline including start and finish dates. Indicate if the timeline is flexible.

This project should be able to be completed within 60 days of receipt of funding. If funded in October of 2025, this project will be started immediately with an anticipated finish date of December 31, 2025. This timeline is flexible.

There are no other funding partners currently. AZ City Moose Family Center will inform GRIC if any come forward.

9. Would you be able to implement the proposed plan if your organization received partial funding for this project?

Any partial funding of this project will be used towards completing this project. AZ City Moose Family Center will continue to seek ways to finish the project if it is only partially funded by GRIC.

10. Describe your plan for project financial sustainability beyond the grant period. If this is a program/project previously funded by the Gila River Indian Community, describe efforts made towards the previously described sustainability plan.

AZ City Moose Family Center has been an established program in our community for many years. We anticipate that when our kitchen remodel project is complete that our members and our community will continue to support our family center and the programs that it provides.

Once funding is in place a detailed project timeline will be defined. Progress will be logged on to the timeline as each part of the project is completed. A separate spreadsheet detailing the start date, completion date, and expenses will be created and updated weekly as needed until the project is complete. (f/k/a Supreme Lodge of the World, Loyal Order of Moose) in its Publication 78, revised January 1986 (and thereafter), which contains a list of Organizations described in Section 170 (c) of the 1954 Code, as a Fraternal Organization.

May 29, 1940

Based on the information supplied, we rule that the new subordinates you recently submitted for addition to your group exemption roster are exempt from Federal income tax under section 501(c)(8) of the Internal Revenue Code. This ruling supplements your original group exemption letter.

Each subordinate is required to file Form 990, Return of Organization Exempt From Income Tax, if its annual gross receipts are normally more than \$5,000. If filing is required, and if you do not include the subordinates in a group return, each must file the Form 990 by the 15th day of the fifth month after the end of its annual accounting period.

The new subordinates are not required to file a Form 1120 income tax return. However, if they are subject to tax on unrelated business income under section 511 of the Code, they must file Form 990-T.

The new subordinates are liable for social security taxes under the Federal Insurance Contributions Act and, if they employ four or more individuals, for the tax under the Federal Unemployment Tax Act.

Individuals may deduct contributions to your new subordinates, as provided in section 170 of the Code, if the contributions are for the charitable purposes specified in section 170(c)(4) of the Code. Bequests, legacies, devises, transfers, or gifts to or for the use of the new subordinates are deductible for Federal estate and gift tax purposes under sections 2055, 2106, and 2522 of the Code if they are for the charitable purposes specified in sections 2055(a)(3), 2106(a)(2)(A) (iii), and 2522(a)(3) of the Code.

  - b. was deleted from the roster; or
  - c. was added to the roster.

A directory of subordinates may be substituted for this list if it includes the required information and identifies the affected subordinates according to the three categories above.

- 3. For subordinates added to the roster, a letter signed by one of your principal officers containing or attaching:
  - a. a statement that the information upon which your present group exemption letter is based applies to the new subordinates;
  - b. a statement that each has given you written authorization to add its name to the roster; and
  - c. a list of those to which the Service previously issued separate rulings or determination letters relating to exemption.
  - 4. If applicable, a statement that your group exemption roster did not change during the year.

Supreme Lodge of the World, Loyal Order of Moose,

Mooseheart, Illinois.

Sirs:

Reference is made to the evidence submitted by you in order that the status of the various individual units of your organization which are known as Lodges, Legions and Chapters, may be determined for Federal income tax purposes prior to a determination of their status for employment tax purposes.

The records of this office disclose that under date of August 15, 1935, the Bureau held your organization to be entitled to exemption under the provisions of section 101(3) of the Revenue Act of 1934 and prior revenue acts, as a fraternal beneficiary society, operating under the lodge system, and providing for the payment of benefits to your members, or their dependents.

It appears that the activities of your organization are conducted through individual units which are known as Lodges, Legions and Chapters. Each of the local units are autonomous units operating under identical charters granted each unit by your corporation, which is the national headquarters of the fraternal system known in the aggregate as the Local Order of Moose. The individual units in active operation as of Earch 31, 1940, numbered 150 Legions, 810 Chapters and 1,355 Lodges.

In view of the foregoing, it is held that the Legions, Chapters and Lodges chartered by your organization are such organizations as come within the provisions of section 101(3) of the Internal Revenue Code (53 Stat., Part 1) and section 101(3) of the Revenue Act of 1938 and the corresponding provisions of prior revenue acts. Income tax returns will not, therefore, be required to be filed for 1939 and prior years and returns will not be required for subsequent years so long as there is no change in their organization, their purposes or their method of operation which would affect their exemption from income tax.

Supreme Lodge of the World, Loyal Order of Moose.

Any changes in the form of organization or method of operation of any one of the Logions. Chapters or Lodges chartered by your corporation must be immediately reported to the collector of internal revenue for its district in order that the effect of such changes upon its present exempt status may be determined.

The exemption referred to in this letter does not apply to taxes levied under other titles or provisions of the Code, or of the respective revenue acts, except insofar as exemption is granted expressly under those provisions to organizations enumerated in section 101 of the Code, or section 101 of the Revenue Act of 1938 and the corresponding sections of prior revenue acts.

This Eurem should be advised immediately of any additional Legions, Chapters, or Lodges, chartered by your organization, as well as the cancellation of any charter issued by your organization on or after the date of this letter.

The question of the status of the respective Legions. Chapters, and Loages chartered by your organization for employment tax purposes will be made the subject of a separate communication.
