1. Briefly describe your organization's history, mission and goals.

The Pinal County Veterans Memorial Foundation was established in 2009 and officially received our 501c3 designation in 2010. From that time the organization was developing the plan to build a memorial park to recognize the men and women that died in action from Pinal County. Many years were spent raising awareness and funds to help construct the project. There still was no location set and in 2017 The city of Casa Grande entered into an agreement to partner with us. We are construction the project on Pinal Ave which is a major road to enter the City this allows easy access for visiter. We Completed plans in 2018 and held a groundbreaking on Veterans Day 2019. Once COVID shut everything down and increased expenses we were back to the drawingboard. We Have been completing the project in mini phases to ensure our funds are being used appropriately and wisely. With the Help of Pinal County and a Gila River Indian Community Grant we were able to complete the Retaining walls and Flag poles to help bring shap and vision to the site. Over the next couple years we went out to the community to help find funding sources for the next phase. And with growing support we moved forward with the construction of the memorial circle. If you visit the site you will see this is an amazing display to show honor to our fallen Heros. It is our goal to complete the memorial park to allow every one to come remember and show respect. The Pinal County Veterans Memorial Foundation's purpose is to never forget the men and women that Died in Action from Pinal County along with honoring all Veterans. We have a book with the 174 names of Veterans that enlisted from Pinal County and never returned. From there we worked to get as many stories from the life of the veteran. Where they grew up, where they went to school, and any other details that



would allow us to show that it is not just a name on a wall but a neighbor, a friend, an actual person that has a story. We Are serving the County through honor and dedication. This is a public park for all to enjoy. We hope to hold cerimonies to and other public presentations to help in our cause to "Never Forget those who died fighting for our freedoms".

3. Describe the proposed project, objectives, and your plan to implement.

The request for funds is to complete the landscaping of the project. Due to the size of the project of just over an acre of land there is much to be developed. We intend on completing the construction of the structure and sidewalks. Once complete the site will be lacking surrounding vegetation. Included is the bid from a local landscape company that will allow us to bring beauty to the park and allow for peaceful reflection

One of the areas is Education. The Book Our Fallen Heros is designed to give a back story on as many of the 174 men and women that will be displayed on the wall. Allowing local schools and community members to know more about the veterans and give a face so it is not just a name on a wall. Also, there is a passion for honoring worriors. Growing up hearing stories of Ira Hayes and getting to look up to many others that defend our country has fueled our organization to uphold the mission to never forget these men and women. I believe that this is where we align.

Over the years we have had the opportunity to hear from many Veterans. I think that our organization can be summed up by the workds of one longest standing board members Bob Souza "one of the biggest fears faces in battle is whether anyone will remember you" Our mission is to never forget and educate the community on the sacrifices our family, friends, and neighbors gave to allow us to live free.

GRIC has previously funded the project. We received funds in 2023 to help complete the Flag Poles. The project is not set up to be continuing as far as funding. Once the memorial is completed there will be no additional funding needed. We have community partners that will help maintain the property.

Our estimated Timeline will be as follows. Once the Grant is approved we will begin the construction of all landscaping. Estimated time for completion would be within 60 days.

We continue to meet with community leaders and business owners to develop partnerships to complete construction. Thank fully the City of Casa Grande has agreed to help with the ongoing maintenance was the memorial park is completed.

The project has approved plans from the city of Casa Grande Building department. This allows us to track the completion of each phase and ensure work is being completed appropriately. We continue to document each phase of the project and use social media to help promote and raise money. We will be able to provide completed photso and billing invoices for each step of the construction phase.
