Dear AZDOHS Stakeholders.

The FFY 2025 SHSGP and UASI application portal is open! Grant Information Seminars (GIS) are being held on January 7, 2025 in Flagstaff, January 8, 2025 in Phoenix and January 9, 2025 in Tucson. If you were unable to attend, we encourage you to review the information and attachments provided in this email.

A few things to note:

1. The due date for FFY 2025 SHSGP applications is: **5:00 pm on Friday, February 28, 2025. Late applications will not be accepted.** If you have projects that have a terrorism nexus, we would encourage you to apply.

- 2. We anticipate the five (6) National Priority areas to be the same as FFY 2024. They are:
  - a. Enhancing the Protection of Soft Target/Crowded Places
  - b. Enhancing the Information and Intelligence Sharing and Analysis
  - c. Combating Domestic Violent Extremism
  - d. Enhancing Cybersecurity
  - e. Enhancing Community Preparedness and Resilience
  - f. Enhancing Election Security

We, as a collective state, need to allocate a certain percentage of our state funding to projects that address these six categories. Please do not assume that we will have enough projects to meet this threshold. If you have needs here, please apply! Projects that do not fall within these categories will also be eligible for funding.

- 3. We have not yet been notified of Arizona's allocation for SHSGP funding. Last year's allocation to the State was \$4,362,750 and we anticipate something close to that number. You can assume something close to that number again this year.

- 5. Finally, as you are working on your application, you will find two buttons- one for Save Progress and one for Finish/Submit. If you need to leave your application and come back to it later, hit Save Progress. You can do this as many times as needed. Only hit Finish/Submit when the application is 100% done. Once you hit this button, you cannot go back in and edit anything.

If you are interested in applying for FFY 2025 SHSGP or UASI funds, you will need an online application account. 
