*A county recorder or officer in charge of elections shall designate a polling place as an emergency polling place and thus prohibit persons from electioneering and engaging in other political activity outside the of the 75 foot limit prescribed by A.R.S. § 16-515 if the county has exhausted all options and there are no suitable facilities willing to be a polling place without the emergency designation.

[†]This facility has been utilized over the years due to a lack of available facilities within the boundary lines of Precinct 26. There are no alternative facilities that will meet either the ADA requirement, appropriate spacing needs, parking, or availability. Desert Willow Church of LDS is the closest facility in this intensely residential area able to accommodate the number of voters residing in the precinct.
