Against Abuse, Inc. Response to the Ak-Chin Indian Community 2025 Prop 202 – 12% Contribution Grant Application

A. Purpose of Grant.

1. Describe the proposed project

AAI has been receiving State and Local Fiscal Recovery Funds (SLFRF) funds to meet a variety of needs for victims of domestic and/or sexual violence, dating violence, stalking and trafficking. As a result, victims have been able to achieve safety, mitigate homelessness and food insecurity, apply for work, address the requirements of their legal issues, address their medical and behavioral health needs, and more. Unfortunately, the SLFRF funds will terminate July 31, 2025.

When victims approach us for services and support, they present with a variety of circumstances and individualized set of needs. Sometimes, victims have a safe place to escape to that may or may not be local and may even be in another state or even country and need funds for emergency travel fare and food during the trip. Often, because of an emergency escape to safety, they come to us with only the clothes on their backs and need clothing, food and baby-related supplies (bottles, diapers, formula, etc.) As a result of their trauma, they need counseling and therapy to help them cope and heal. As a result of their abuse and/or neglect, they may need medical attention, replacement of glasses or dental work. As part of their financial abuse and isolation, they come to us unemployed and may need clothing for interviews, funding for pre-employment course work, certifications or other work-related or education-related fees. Sometimes they need a cell phone to make and receive important calls from potential employers, lawyers, medical personnel, educators from their children's school, etc. If they have a vehicle, they may need initial or temporary help with gas, tire replacement, battery replacement, general repairs, car payments, vehicle insurance payments, etc. If they don't have a vehicle, they may need funds for transportation, such as, but not limited to, Lyft or Uber to get to interviews, classes, appointments, etc. If they are staying in a motel, they may need help with food and even quarters for laundry. If they are in their own home, sometimes they need help with food, back payments of rent or mortgage and utilities, HOA fees, as well as internet expenses to help mitigate their homelessness and/or food insecurity. They may need help replacing broken windows or doors, replacing locks, or installing security cameras. When they are involved in legal requirements and/or proceedings, they may need financial help with legal fees, obtaining and/or filing documents, transportation to and from court or appointments with their lawyer.

Based on AAI's QuickBooks Direct Assistance Report, below is a table that demonstrates the many reasons for which we were able to provide flexible financial assistance for victims during Fiscal Year 2023-2024.

2. <u>Identify the target population that will be served by the Project.</u>

The population in Pinal County that will benefit from this funding would be those who are victims of domestic and/or sexual violence, trafficking, dating violence and stalking and are receiving services from AAI. To determine the degree of incidence of domestic and sexual violence in Pinal County, AAI requested data from a variety of law enforcement agencies. Though we did not receive reports from all of them, below is a table indicating that, in 2024, in aggregate, those law enforcement agencies that provided reports responded to 1,668 calls from victims of domestic and/or sexual violence.

3. Describe the Project goals and objectives and outline a plan to meet these goals.

The project goal is to provide Flexible Financial Assistance to victims when they are in need of financial assistance to:

- a. Establish immediate and ongoing safety
- b.Mitigate homelessness and/or food insecurity
- c. Comply with legal fees and requirements
- d.Provide transportation or transportation related support
- e. Provide employee and/or student-related expenses
- f. Provide individualized miscellaneous flexible financial assistance as needed

To meet these goals, staff will meet with clients to identify the need for Flexible Financial Assistance. If the victim is eligible, the staff will complete a Purchase Request (PR) form for approval and processing. The Finance Manager will provide the funds as requested on the PR. Utilizing QuickBooks, the Finance Manager will keep track of the amount being used and the amount remaining in the fund and communicate this information to the Associate Director who will convey it to the Leadership Team on a regular basis during weekly team meetings.

4. Provide a timetable for implementation of the Project.

AAI will begin administering Flexible Financial Assistance on an as needed basis beginning in January of 2026. Due to the unpredictable nature of victims' needs, AAI will continue to administer Flexible Financial Assistance until December 31 of 2026 or until the funds have been exhausted, whichever comes first.

B. Resources

1. Current Funding Sources

AAI has been receiving one-time SLFRF funds to meet a variety of needs for victims of domestic and/or sexual violence, dating violence, stalking and trafficking. Unfortunately, the SLFRF funds will terminate July 31, 2025. AAI receives very small amounts of ongoing Flexible Financial Assistance from DES: We receive about \$5,000 for victims of domestic and/or sexual violence and \$11,000 which is limited to victims of sexual violence. Though helpful, these funds barely scratch the surface compared to the actual need of victims.

2. <u>Identify other organizations or partners that are participating in or contributing to the Project, but which are not funding sources, and describe their roles or contributions.</u>

As AAI has been a member of the Pinal County Community since 1981, there are a number of organizations or partnerships that have helped us provide victims services and support. For example, many of the local motels, such as Mainstay, partner with us by providing discounted rates during their slow seasons. A number of auto repair shops provide discounts for tire replacement and general vehicle repair, such as Brakemasters, Tire Solutions, Johnny's Auto, Big Joe's Tires and Oil Depot. Arizona@WORK partners with us to help provide victims employment related support and education. Banner Hospital works with AAI when a victim needs a SANE exam after a sexual assault. Pinal Hispanic Council, Helping Associates, Community Bridges provide crisis and/or ongoing behavioral health support on a sliding fee basis. AAI has a strong relationship with prosecutors that have significant experience providing advice or court representation. Some lawyers, such as the Palmer Law Group and SALA (Southern Arizona Legal Aid) offer their services pro bono or at discounted rates. The Pinal County Housing Authority, the Pinal County Homelessness Coalition and HomeInc help when it comes to finding affordable housing. Many day care facilities work with us so their parent can go to school or

work, Sun Life Preschool, Passion Preschool. They work with us by making "promise to pay" arrangements. The Bargain Hut thrift store and the Casa Grande Alliance provides vouchers for discounted clothing. The Casa Grande elementary school homeless liaison provides transportation to and from school, backpacks, hygiene items and school clothes for children. The Casa Grande Food Bank and St. Vincent de Paul provide some food boxes. Foothills bank provides free financial classes. The UofA provides free nutrition classes at our shelters. AAI works with WIC (via the Pinal County Health Department) for nutritional education.

3. <u>Define the Project as a new or continuing project or a purchase.</u> Provide information about how the Project will be sustained or the purchase will be maintained after the grant funding is exhausted.

This is a continuing project. After the funds from this project have been exhausted, we anticipate including a line item for Flexible Financial Assistance as a routine practice in grant applications going forward. We may also allocate donated funds to support this project on an ongoing basis.

AAI is submitting a similar request to the currently open Tohono O'odham Nation request for proposals (due June 9, 2025). We do not know if we will be awarded, whether fully or partially. We hope to be awarded by both requests to provide support to more victims as they need Flexible Financial Assistance.

- 2. The AAI staff will complete a Purchase Request (PR) to include details regarding the nature of the expense, the address, the amount, etc.
- 3. The PR will be submitted to the Program Director for review and approval. The Program Director will determine if the expense falls within the guidelines of the project and if there are sufficient funds in the budget to provide the FFA. If the request is appropriate, the Program Director will sign their approval and submit the signed PR to the Finance Manager.
- 4. The Finance Manager will review the PR to ensure all signatures are in place and all necessary information has been provided. The Finance Manager will provide the FFA in the format requested, whether by direct payment, gift card, check, etc.
- 5. The Finance Manager will document the transaction in QuickBooks and file all related documents.
- 6. The Finance Manager or the Associate Director will provide QuickBooks generated reports regarding the amount available in the budget for ongoing FFA requests.
- 7. The Finance Manager or Associate Director will provide a final report, upon request, to include all transactions, and information such as the date, the amount spent, what the funds were used for, etc.
