Hope Women's Center Proposal for The Ak Chin Community 2025

Executive Summary

Underserved women in Maricopa face a range of adversity — addiction, domestic abuse, sexual abuse, unplanned pregnancy, and homelessness. When left unhealed, these traumatic experiences create vicious cycles of poverty, abuse, and neglect for women and their children. When these women are also mothers, these crises can lead to adverse childhood experiences, and potential involvement by the Department of Child Safety.

Hope Women's Center has found that mothers who receive appropriate support are able to keep their families together. That's why we recently expanded our Hope Initiative/Every Mother's Advocate program to serve women who are at risk of family separation. We provide mothers with the education, counseling, and case management they need to keep their families together.

As our clients find stability and support, the demand for the program has only been growing. To continue offering these mothers the support they need, we request a grant of \$10,000 from the Ak Chin Indian Community.

Hope Women's Center has never received a 12% distribution from the Ak Chin Indian Community or any other Arizona Tribe. We plan to work with Pinal County as a fiscal sponsor.

Mission of Hope Women's Center

Hope Women's Center exists to engage, encourage, and equip women and teen girls facing any difficult life situation by providing support for her physical, emotional, and spiritual needs. As we refine and expand the work of Hope Women's Center, it is our longing to see our clients, and their community, profoundly transformed.

The Need in Maricopa

In December 2020, Hope Women's Center opened a center in Maricopa. We chose Maricopa because it is one of the fastest growing cities in Arizona, which always leads to increased levels of inequality. The programs offered at our Maricopa center take a holistic approach to help the underserved women in the area regardless of the challenges they face.



In 2023, Hope Women's Center identified an increased need across the state of Arizona to help stabilize families before an intervention from the Department of Child Safety was needed, and we expanded our Hope Initiative program to increase focus on stabilization and better meet the needs of the women we serve.

In 2022, the Department of Child Services identified 22,000 Arizona families who were at high risk of needing intervention. DCS got involved with a quarter of those families, which led to 3,400 kids being placed in foster care. These interventions are often necessary, but that does not make them any less traumatic for the family, and for the children. Thousands of lives are being tragically disrupted, and we know that these traumatic events have the power to affect women and children for the rest of their lives. However, we have found that when women and families receive prevention and interventional support and advocacy, their outcomes for family health, remaining intact and reunification increase.

Sadly, women in these situations typically don't have any support at all. The complicated process to avoid foster care or to reunify a family makes support so necessary. Requirements include paperwork, classes, meetings, court hearings, proof of employment, to name only a few. These kinds of steps are hard to manage for someone with stability, let alone someone who is likely struggling with poverty and unhealed trauma.

It doesn't have to be this way. With the right support, women in crisis can achieve steady employment, reunification with their children, and keep a stable family environment with improved parenting and life skills.

Our Solution: The Hope Initiative

HWC has responded to the shortcomings in the system by expanding the Hope Initiative as an affiliate of Every Mother's Advocate (ĒMA). ĒMA is a program that partners with missionaligned affiliate organizations to eradicate the preventable causes of family separation through mother advocacy.

Hope Initiative/Every Mother's Advocate (ĒMA) is a Hope Women's Center program that seeks to eradicate the preventable causes of family separation through mother advocacy. The ĒMA program is an evidence-based, court-approved prevention program designed to empower moms in crisis to preserve their families. Hope Women's Center, as an ĒMA affiliate, trains staff members who are able to identify and pair at-risk mothers with our ĒMA-based programming. The program supports mothers through a two-prong approach — advocacy and case



management. This includes pairing each mother with a certified volunteer Advocate who offers social, emotional, and tangible support in weekly meetings. These trained EMA volunteer Advocates provide individualized and comprehensive support services — empowering moms to achieve stability and keep their families together.

This partnership will allow us to serve more mothers and make a greater impact on children involved in the child welfare system. As an EMA affiliate, HWC receives training and resources for this specialized program, and will care for mothers who are facing losing their children (prevention) and mothers who are working to reunite with their children (reunification). Thus, the specific objectives of the program are two-fold:

- 1. Prevent removal through our programs, mentorship, job coaching, case management, etc.
- 2. Increase reunification after removal happens in the first 18 months.

In 2024, over 29 women in Maricopa took advantage of our Hope Initiative/ĒMA program, which has sparked the need for more dedicated time from an EMA Manager at our Maricopa Center.

Who is helped?

During 2024, our Maricopa Center served over 157 women in 1700 visits.

Economic Demographics

93% of the women who come to our Maricopa Center make less than \$14,000 per year.

Age Demographics

87% of our clients are between 20-60 years old.

Ethnic Demographics

12% of our clients are Native American30% are African American30% are Hispanic16% are Caucasian12% are Multi-racial or Other

Geographic Demographics

96% of our clients live in Pinal County, while 3% are homeless.


