Grant Summary

Apache Junction Reach Out, Inc. DBA, the Superstition Community Food Bank, seeks **\$15,000 in funding** to support the **Fresh Pick Project**, an initiative aimed at increasing access to fresh fruits and vegetables for individuals and families in need. Our food bank primarily relies on generous food drive donations, which often consist of highly processed, shelf-stable items high in sodium and preservatives. While these products serve an important role in food security, they lack the vital nutrients necessary for maintaining a healthy diet.

Inspired by the message shared by *Jonathan Nez of the Navajo Nation* at the **2025 Arizona Food Bank Network Conference** that "**Food is Medicine**," we recognize that providing fresh produce will empower our clients to make healthier food choices and prepare nutritious meals. This initiative will allow us to improve the quality of food distributed while supporting community health, wellness, and insecurities.

Statement of Need

The Superstition Community Food Bank plays a critical role in addressing food insecurity, serving **44,301 individuals and 16,445 households** in 2024 alone. Our organization is uniquely situated in **Pinal County** yet serves both **Maricopa and Pinal County residents** due to its location within the Phoenix-Metropolitan area.

Food insecurity disproportionately affects low-income households, where access to fresh produce is often limited. Poor nutrition contributes to chronic health conditions such as *diabetes, obesity, and heart disease*. By introducing fresh fruits and vegetables into our food distribution efforts, we aim to **combat nutritional deficiencies and promote healthier eating habits** within the communities we serve.

We have established strong partnerships with the *City of Apache Junction*, local schools, and organizations such as *CAHRA, CAAFA, and A New Leaf*, allowing us to reach a broad audience. This initiative will further enhance our ability to provide **fresh, nutritious food options** to individuals and families in **Apache Junction, Gilbert, Gold Canyon, Mesa, San Tan Valley, Superior, Queen Creek, and Queen Valley**.

Project Description

- **Objectives:**
 - Increase access to fresh produce for food-insecure households.
 - Educate recipients on the nutritional benefits of fresh food and meal preparation.
 - Strengthen partnerships with local farmers, grocers, and food distributors.
- **Methods:**
 - Develop partnerships with growers, wholesalers, and local markets to source fresh produce.
 - **Integrate fresh food options into existing distribution programs.**
 - **Provide educational resources to encourage healthy meal preparation.**
- **Timeline:**
 - **Phase 1:** Secure funding and finalize supplier partnerships (Months 1-3).
 - **Phase 2:** Begin procurement and integrate fresh produce into distribution efforts (Months 4-6).

- **Phase 3:** Monitor progress, provide educational support, and evaluate impact (Months 7+).

Budget

The total cost of the **Fresh Pick Project** is **\$50,000**, funded through multiple sources.

The requested funding will be allocated as follows:

- **Produce Procurement:** \$50,000
- **Educational Materials & Outreach:** \$2,000 (Covered by Food Bank)
- **Administrative, Storage & Distribution Costs:** \$0.00 (Covered by Food Bank)

We know that many qualified organizations are applying for funding, partial funding will also be appreciated, once again, **ALL FUNDING will be spent to purchase produce.**

*We have also applied for \$15,000 from the *Tohono O'odham Nation's 12% Gaming Grant*.

We are seeking **\$15,000 in additional funding** from the *Ak-Chin Indian Community* to complete our budget for the **Fresh Pick Projects** initial launch and first year.

We have applied for the *Gila River Indian Community 12% Gaming Grant* in the past but have never been awarded any funding.

Evaluation & Reporting

We will track the program's success through quarterly reporting:

- **The number of households served fresh produce.**
- **The quantity and variety of produce distributed.**
- **Regular reporting to funders detailing challenges, successes, client feedback, spending and improvements.**

Conclusion

The **Fresh Pick Project** represents a transformational shift in our food bank's approach, prioritizing health and wellness alongside food security. By providing fresh, nutritious produce, we aim to **improve lives and promote lasting health benefits** for those facing food insecurity.

Dear Sir or Madam:

We're responding to your request dated March 05, 2025, about your tax-exempt status.

We issued you a determination letter in November 1988, recognizing you as tax-exempt under Internal Revenue Code (IRC) Section 501(c)(3).
