Ak-Chin Indian Community 2025 Prop 202 – 12% Contribution Grant Application Narrative for the Tranquil CommUNITY Garden at the United Methodist Church of Casa Grande

A. Purpose of the Grant

- 1. The proposed Project is to construct and maintain a community garden with beds to plant vegetables, flowers, and herbs; as well as an area with walking paths, trees, benches, and reflection areas. It is our objective to make available to the people of Casa Grande, 1) access to a place of peace, comfort, relaxation and reflection, with 2) sustainable gardening facilities and fruit trees for not only their individual mental, physical and nutritional wellbeing, but to also 3) serve those with food insecurities through our donations to the local food bank, and 4) provide products to be used by the culinary program at the local community college; with a facility and focus to, 5) promote and conduct sustainable urban agriculture and gardening educational programs highlighting the need for healthy eating habits, as well as, 6) conducting hands on application and education of effective water resource management. We plan to implement action plans to achieve each of these objectives by combining financial resources (current and future) and effective personnel (with the necessary desire, skill, and abilities) to successfully carry out the current and future vision of the gardens and their intent.
- 2. It is our intent to create a safe space for persons of all ages, socioeconomic standing, races, religions and ethnicities to get away from the hustle and bustle of the city or to step away from the stress of work, school, homelife or any situation where they feel the pressures of real life or the adverse effects of persecution or shame. A place that is accepting to all that allows anyone to come and take a deep breath, reflect on their personal situation, and plan what is next. We will do our part to break down the established structural inequities to ensure that an equity lens informs all decision making, programs, policies, and guidelines. We will embrace I.D.E.A. principles with an eye on Inclusion, Diversity, Equity and Access.

In addition to creating this safe space, we will be creating a garden area with access for all people in our community. With smaller homes and apartment living, few people now days have the opportunity to garden and receive the positive effects received from gardening. Gardening has been found to alleviate the adverse effects of stress and this return to nature cultivates positive emotional bonds. Gardening creates a connection to nature by decreasing levels of anxiety and depression, improving focus and attentiveness, evoking a favorable physiological response beyond what mere images of nature can induce, and boosting the immune system. Ecotherapy, sometimes referred to as nature therapy or green therapy, is a developing field in mental health and overall well-being. It leverages the therapeutic potential of the natural world to enhance psychological, emotional, and physical health.

This sustainable agriculture will also be going to the local community college culinary school to be used by what we hope to be future chefs to ready them for a good career, with a good income to help them to be good citizens that can carry on the ideals that are a core to the purpose of this worthwhile Project.

The neighborhoods surrounding the proposed site have limited access to grocery stores and other fresh food retailers as it is adjacent to a USDA low-income, low-access food desert, meaning more than 10% of residents do not live within walking distance of a supermarket and are without a vehicle. In addition to our garden being this safe and therapeutic space, a portion of the produce raised by these caring hands will not only go directly to those that are facing food insecurities, but this fresh produce will also go to the local food bank.

As far as the number of people served by the project, as we have not targeted a certain group, we have no idea how many people will be directly and indirectly impacted by the Project, but we hope it to be 200+people living at or near the Project site in center of the city of Casa Grande Arizona.

For these reasons and with these intentions, the United Methodist Church of Casa Grande is working to develop, build and maintain this Community Park with Vegetable and Reflection Gardens to bring these much-needed resources to the community.

3. As this is a new project we have not yet established numerical goals, but we have established objectives we hope to achieve.

We hope through this Project to create, promote and maintain a safe place for the under-privileged, underserved, special needs and those marginalized by welcoming them to this area to have a place that is accepting to all and allows anyone to come and take a deep breath, reflect on their personal situation and plan what is next- without judgment, without cost and without prejudice.

We hope that the school for which we are partners at this site, Bridges Learning Center, will use this place for their special needs students to "burn off some energy" as the teachers have mentioned is needed. The school will also use this place to help these students and their teachers to achieve their goal of "creating a nurturing environment, dedicated to empowering students with diverse learning needs and help to unlock the potential of each student, fostering independence, and building confidence to overcome challenges".

We hope that others in the community will find this area a safe space to get away from the hustle and bustle of the city or to step away from the stress of work, school, homelife or any situation where they feel the pressures of real life or the adverse effects of persecution or shame. A place that is accepting to all and allows anyone to come and take a deep breath, reflect on their personal situation, and plan what is next.

We hope to become a source and resource for both online and hands-on education opportunities to the general public and agricultural professionals by promoting and conducting urban agriculture and gardening educational programs. With the help of the University of Arizona School of Agriculture Cooperative Extension Service, we hope to help those that have an interest in environmentally responsible landscaping and gardening, as well as the application and education of water resource management in cooperation with the Central Arizona Project of Arizona.

We hope to become a source of sustainable agriculture for persons in the community that are facing food insecurities by allowing them to use this garden area to grow food for themselves and their families to be able to have fresh fruits and vegetables, at little or no cost, to help sustain them physically as well as create the positive mental effects that gardening offers that was mentioned previously.

We hope to create positive connections within the community by serving not only those with food insecurities directly, but also by providing fresh fruits and vegetables, at no cost, to the local food bank. We will continue this community connection by supplying the local community college culinary program with these fruits and vegetables for use in their programs. Once again connecting the community to our Community Park with Vegetable and Reflection Garden.

We Will Measure the Project Success to our Objectives by

- Comments written in a Guest Register or dropped in a comment box
- The number of people or families that register to use the gardens facilities for their own use and their recurring use through the reenrollment process recognizing their enjoyment of the facilities
- The quantity, amounts and frequency of fruits and vegetables donated to our Partner organizations

- The types and number of educational classes, programs and informational sessions conducted and attended.
- 4. We began initial steps in designing and in the initial construction of this Community Garden back in March of 2025, with the limited funds we had to do so.

We hope to raise additional funds by September 2025 to open the Gardens to the public and begin our objectives of serving the people in the neighborhoods which hope to serve.

From October 2025 until December 2025, we hope to have the garden space available for planting.

From December 2025 through March 2026, we imagine the gardens will be dormant, but the rest of the Garden Paths and Park Amenities would be open for use by those we are serving.

Gardening will again begin on or around April 2026 and will continue until we anticipate June 2026.

The planting will subside in June through August, then we will once again open up the Gardens for planting in September 2026.

This project will be year-round, with no end date anticipated as long as we have continued funding for the CommUNITY Gardens. As the Gardens and Walking Paths will be open year-round, on an ongoing basis going forward, we will continue to seek ongoing funding to not only maintain this project but to also expand and enhance this project

B. Resources

- 2. Other organizations or Partners that are participating in or contributing to the Project, which are not funding sources include:
 - The University of Arizona Cooperative Extension Services Assisting with design, construction, and ongoing operations of the Project, including assistance with staffing and a public education resource.
 - TriValley Landscaping Assistance with design, construction, and ongoing operations of the Project.
- 3. This Project is a new construction and will be sustained and maintained, after the initial grant funding, by ongoing solicitations to the church members, the Garden users, and through future grant funding requests. We do hope to have 2-year operating and maintenance costs raised during this initial construction period to allow the operations of the project to continue, as future funds are raised.

Grant funds for this Project have been requested from the Gila River Indian Community 2025
 Prop 202 Grant Funding. No other current or past funding has been requested by this or any other Arizona tribe for this Project.

Reports

The Project's Income and Expenses will be tracked digitally using generally accepted accounting software. This accounting software will allow all expenditures for this grant funding to be accounted for and reported to the Community as required.

The Project progress and results will be tracked with the committee and people tasked by the Church to do so. A minimum of quarterly meetings will be required to discuss, review, report, and document this Project and these results to be reported to the Church's Administrative Board as well as to other stakeholders and Partners.

D. Budget

The Total Initial Budget for the Project is as follows. Each of these individual and grouped budget items have been researched, sourced, contracted, evaluated, and estimated to make certain they are a fair and reasonable cost, and that they are what is required and justified to construct and maintain the Project.

This refers to the information submitted for use in determining your status and the status of your affiliated religious organizations, on the list you submitted, as being exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code.
