Proposal for Ak-Chin Community 2025 Prop 202-12% Contribution Grant

A. Purpose of Grant

1. Description of proposed project including needs/issues the project will address.

The Pinal County Family Advocacy Centers (FAC) were created to provide an array of services to crime victims in one private, child and family friendly, victim-centered location. There are currently three centers in San Tan Valley, Eloy and the City of Maricopa and one satellite center in the rural community of Oracle. The centers provide services to both children and adults for concerns of abuse and interpersonal violence. Children are seen at the FAC as a part of a law enforcement and/or Department of Child Safety (DCS) investigation after an allegation of child abuse. Child witnesses to abuse or violence also receive services. Those services include Forensic Medical Exams, Forensic Interviews and Victim Advocacy. Adult victims are seen at the FACs for concerns of acute sexual assault as well as other interpersonal violence, specifically strangulation. Adults may be referred for sexual assault or strangulation exams by law enforcement or may self-refer for sexual assault exams if they choose not to report to law enforcement. Adult victims receive medical forensic examinations and victim advocacy. Some adults may also receive forensic interviews. It is vitally important that Forensic Nurse Examiners (FNE) have all the tools needed to provide a thorough exam, collect and document evidence and document the exam and any findings. At present, the Pinal County Medical Forensics Program utilizes Forensic Electronic Medical Record (FEMR) to document all exams on both adults and children. National Best Practice and Standards for Sexual Assault, Domestic Violence and Strangulation cases have been updated since the last update to the FEMR system and it is important that charting remain up to date with national standards. The medical documentation is used by medical professionals on the team to provide the best medical care for the patient. Law enforcement and the attorneys need this documentation as evidence for charging of a crime and in order to prosecute and seek justice for the victim. Prosecution in turn serves to protect the community and the victim from further victimization. Unfortunately, updates to the medical record system are costly and funding is needed to cover those costs. It is the goal of the Pinal County Family Advocacy Centers to provide the best standard of medical care to victims of crime in Pinal County, including and up to date, thorough and accurate medical record. This project seeks to fund the necessary updates to the FEMR system to bring it up to date with current National Standards of best practice.

2. Identify the population that will be served by the project.

First and foremost, this project benefits victims of crime in Pinal County. An up to date, accurate medical record can be obtained by the victim as well as provided to law enforcement and prosecution in furtherance of justice for the victim. These records are used for court proceedings, court testimony, and for the overall medical care of the victim. Therefore, not only the victim, but law enforcement and prosecution also benefit from the accuracy of the records. And finally, not only the victim but the citizens of the community receive the benefit of increased security and safety when a perpetrator is brought to justice, due in part, to accurate medical records.

3. Project Goals and Objectives

Goal 1: To support victims and community safety through an up to date, thorough and accurate medical record of forensic medical examinations that is consistent with industry best practices.

Objective: Pinal County Public Health will utilize grant funding to support needed updates to the current medical record system utilized by the Medical Forensic team.

Implementation plan: Upon notification of award, Pinal County Public Health will direct FEMR, the current medical record provider, to make the requested updates to the medical record system as prescribed in the attached estimate. Payment will be made upon completion of the project.

A quote was obtained from FEMR and is attached (Attachment 1) to this grant application. The quote details the needed changes and the cost for the change by chart type as listed above. The total cost for this project is \$22,625.00. If awarded, work would be authorized upon Board of Supervisors authorization of grant agreement. The organization governing the FEMR system has a 30 to 60 day backlog to being the work and the work would take approximately 90 days. Therefore, we estimate that the project would be completed in November of 2026 with payment made shortly thereafter. Grant reporting will then be completed by the end of 2026.
