6. Description of Project: Detail what the project will accomplish.	In January of 2022 we received a Case Backlog Reduction Grant that we used to fund several Senior Commissioners. Eight retired judges were appointed and two of them have been extremely helpful in reducing our backlog an covering vacant caseloads when two of our judges were promoted to the Court of Appeals. The original grant was for \$136,519 and approximately \$133,000 has been utilized as of today. The Grant is set to expire on June 30, 2024. During the past nine months we have used approximately \$7,000 per month. We are requesting an additional \$56,000, with a new expiration date of December 31, 2024. This will allow the current Senior Commissioners to complete the cases they have been working on.
