OUTLINE

A. Purpose of Grant.

1. Describe the proposed program, project or purchase (collectively, the “Project): The Pinal County Sheriff’s Office (PCSO) respectfully requests grant funding for the purchase of updated rifle optics and mounts to replace equipment currently in use by Deputies. The optics currently deployed are over 25 years old, no longer meet modern operational standards, and pose a potential liability due to reliability and performance degradation. This project will fund the purchase of 250 non-magnified red-dot rifle optics suitable for law enforcement deployment. Specifically the Scarlarworks LEAP 1.93 red-dot optics mount and Aimpoint T2 red-dot optic, considered the industry standard for ruggedness and reliability. These optics will enhance Deputies ability to safely and accurately respond to dynamic, high-risk situations, particularly in low-light or rural environments common throughout Pinal County. This grant request is for equipment only – no personnel, salary, or wage-related costs are included. While full funding is requested, PCSO is committed to enhancing Deputy safety and readiness and is prepared to accept partial funding to begin phased implementation of this project. Any level of support will directly contribute to operational effectiveness and public safety.
2. Identify the target population that will be served by the Project: This project will serve all of the communities within Pinal County, including the significant Native American population. Together these tribal nations represent approximately 6.1% of the country rural and sovereign population. Deputies frequently respond to call for service and conduct joint operations in or near tribal lands, making it essential they are equipped with reliable, modern equipment that ensures bother officer and public safety during high-stakes encounters.
3. Describe the Project goals and objectives and outline a plan to meet these goals:
Goal 1 – Increase Deputy Effectiveness and readiness by replacing aging optics.
 - Objective 1 – Procure and install 250 rifle optics and mounts compatible with standard issued PCSO patrol rifles.
 - Objective 2 – Ensure all optics are zeroed and tested by certified armorers and training staff.Goal 2 – Improve safety during critical response incidents.
 - Objective 3 – Provide Deputies with optics and mounts, which support rapid target acquisition in high-stress environments.
 - Objective 4 - Ensure enhances response capability in rural and sovereign areas, including tribal lands, where backup is limited and Law Enforcement Officers may face extended response times. These optics and mounts will improve safety of all Pinal County Citizens by enabling a faster and more accurate response to high-risk situations.
4. Provide a timetable for implementation of the Project:
 - Month 1-3: Solicit updated quotes, finalize vendor, and place purchase order.
 - Month 3-6: Receive, inspect, and inventory optics and mounts.

- Month 6-9: Distribute to Deputies, install and zero optics during regular yearly firearms training
- Month 9-12: Final inspections and performance review; ensure 100% deployment.

B. Resources.

1. This is a one-time capital request and not supported by the existing budget. Full funding is requested from this grant to support implementation.

 - PCSO Training Unit: Will coordinate zeroing, familiarization, training and performance verification.

Once installed, these optics and mounts will be managed and maintained by the PCSO Training Unit and PCSO certified Armorers. The expected service life of each Aimpoint T2 red-dot optic and Scarlarkworks LEAP 1.93 mount is 10+ years. PCSO will budget for replacements in future budget cycles.

Timeline for Expenditure: Funds will be expended within 90-120 days of approval.

PCSO recognizes the limitations on available funding and welcomes partial awards to initiate implementation. If awarded less than the requested amount, PCSO will prioritize distribution to highest-need personnel and units (e.g., rural beats and high-call volume Deputies), and continue to seek supplemental funding to fully complete the project.

E. Additional information: PCSO has a longstanding partnership with the Ak-Chin Indian Community and surrounding Tribal Nations. Our Deputies routinely provide mutual aid or support in areas with limited local law enforcement resources. This equipment upgrade will enhance our ability to serve Native American communities respectfully, efficiently, and safely, honoring the shared priority of protecting life while fostering trust between law enforcement and tribal residents. The Pinal County Sheriff's Office serves a large and growing jurisdiction with a focus on professionalism, accountability and community trust. Upgrading critical equipment like patrol rifle optics and mounts directly support Deputy Preparedness and community safety. PCSO will remain flexible in scope and will responsibly maximize the impact of any amount awarded, recognizing the value and responsibility entrusted by Tribal Communities. PCSO recognizes and appreciated the historical support of Arizona Tribal Communities and the importance of responsible stewardship of any funding awarded. This project reflects out continues commitment to public safety, fiscal transparency and operational excellence. We thank the Ak-Chin Council for its consideration of this request.

Narrative

A. Purpose of Grant.

1. The proposed project is to purchase a Ford Transit van to be upfitted and utilized by the Pinal County Sheriff's Office Traffic Unit for the response and deployment to the investigations of serious injury, liability, and fatality collisions that occur in and around Pinal County. Additionally, the van would be used by the Traffic Unit as needed to respond to critical incidences to assist the Pinal County Sheriff's Office Criminal Investigations Bureau in cases including, but not limited to, homicides, robberies, and officer involved shootings.

This project would replace a 2011 Chevrolet Express van that is currently being utilized as described. The replacement van would improve operations, efficiency, and reliability. The new upgraded van would allow for a desk work space inside the van, more storage of equipment, easier access to equipment, and exterior lighting for night investigations. A new vehicle would allow for reliable transportation with less chances of experiencing mechanical problems.

The Pinal County Sheriff's Office Traffic Unit leads and manages the Pinal County Regional Vehicle Crimes Task Force (PCRVTCTF). This task force is comprised of investigators from seven agencies: Pinal County Sheriff's Office, Queen Creek, Superior, Florence, Coolidge, Eloy, and Maricopa. This task force is a resource available for the serious injury, liability, and fatal crash investigations that occur in all of those jurisdictions. The Pinal County Sheriff's Office provides 10 of the 23 investigators that make up the task force.

Deploying to major collision scenes requires transporting specialized equipment, such as heavy duty weight scales, scene processing equipment including the FARO Scanner and Drone, EDR equipment, evidence markers, safety gear, canopies, barriers, etc. Additionally, for investigations that occur during darkness, a light plant needs to be towed to the scene.

The van would be purchased at a local Ford dealer. From there, it would be transported to another location to be upfitted by a company that specializes in upfitting vans for law enforcement use. This includes installing required emergency lights, interior and exterior lighting, converter for power, computer mount, and a radio that would be purchased as well from Motorola.

Quote sheets and build specs were obtained. However, caution was provided to the applicant contact person, Sgt. Erickson, to account for a 15 percent cost adjustment due to next years model year and potential Tariff consequences.

2. The population served by this project is the citizens who reside in Pinal County and those that commute through Pinal County. The population of Pinal County is approaching 500,000 people. Vehicle collisions can occur at any time and location, and when it does happen, the roadways are closed for the investigation. The people who will benefit include those that are involved in the collision, and those that need to commute around the collision location. The van will allow for the initial reliable response with all necessary equipment so the investigators can work efficiently and open the roadway as soon as practicable. The geographic location includes Pinal County and all municipalities that make up the Pinal County Regional Vehicle Crimes Task Force.

3. The objectives for this project is first to secure a van and complete purchasing after January 1st 2026. If a van is secured in a timely manner, it could be transported to another facility for upfitting in the first quarter of 2026. The upfitting process can take time to complete the van build to specs. The objective for upfitting completion would be the second quarter of 2026. Once completed the van would undergo final inspection before being delivered to Pinal County Sheriff's Fleet Services Department for registration. The objectives for the van to be put into service would be the summer of 2026.

The project goals are to obtain a reliable, efficient, updated van that will improve overall operations in collision investigations that will support and benefit the citizens and commuters of Pinal County. The goal is to maintain the van with required and routine service and repairs as necessary to be completed by Pinal County Fleet Services Department. With proper care and maintenance, the van can be a great asset for 10 or more years, dependent upon accrued mileage.

4. Upon the funded project being approved and fully executed, the Pinal County Sheriff's Office will make arrangements to secure a van that is suitable for our described needs. Once the van is available, it will be constructed per the build specs. When it is completed, and registered by the Pinal County Sheriff's Office, the VCU van will be put into service immediately which would be projected to be the summer of 2026.

B. Resources.

1. Currently, there are no funding sources identified for this project. The cost of this VCU van replacement was not included in a budget item for fiscal year 2026. This project would be a one-time purchase, with long-term advantages.
2. There are no other organizations or partners that are participating with providing the Pinal County Sheriff's Office with a VCU van replacement or upgrade.
3. This project is a new project for the Pinal County Sheriff's Office. The project will be sustained by Pinal County personnel, to include the PCSO staff who will be utilizing the van and Pinal County Fleet Services who will be providing routine maintenance and care to ensure the van is kept in good working condition throughout the years.

The PCSO will keep track of timelines and progression throughout the project until it is completed and put into service. This includes the date of the executed grant, date of purchase order, date a vehicle is secured, date and timeframe during upfitting, date the vehicle is transferred to the Pinal County Sheriff's Office, and date the vehicle is put into service upon registration being completed. Additionally the PCSO Traffic Unit maintains records and statistics for when the vehicle crimes unit is deployed to investigate collisions, and when the van is utilized for case follow up, which includes obtaining vehicle weights and event data recorder information. This information will be available upon request and is updated and current on a monthly basis. This information is tracked by the unit supervisor and the agency records management system.

A. Purpose of Grant.

1. Describe the proposed program, project or purchase (collectively, the “Project): The Community Relations Unit is requesting two Utility Task Vehicles (UTVs) along with two trailers to haul the UTVs. The use of these UTVs and trailers will allow for the Community Relations Unit an opportunity to reach rural and urban areas of Pinal County for community events and the public needs. The vehicles will allow for a closer and personal experience with contact from our Community Relations Unit. This will provide a chance to help and render aid to the county residence when needed and to help and assist with a faster response time in providing resources to the residents of Pinal County in the urban and rural areas of the county.

Identify the target population that will be served by the Project: Pinal County Sheriff’s Office Community Relations Unit is seeking grant funding for two Utility Task Vehicles (UTVs) and two trailers to haul the vehicles while in use. These vehicles will be utilized for easy access to difficult terrain such as the desert, crowded streets, areas that traditional patrol vehicles cannot access with quick efficient time. The UTVs and Trailers will be utilized for emergency situations (such as wildfires) and community events with crowds for the use of transportation of members of PCSO, food, water, or supplies for Pinal County Sheriff’s Office staff and the public. The trailers will be utilized to transport the side by side to the locations it is utilized for transportation of PCSO staff, food, water, and/or supplies for the public and staff.

2. Describe the Project goals and objectives and outline a plan to meet these goals: Pinal County Sheriff’s Office patrols approximately 5,374 miles of both rural and urban areas of the county. The 2024 Census reports that Pinal County has a population of 513,862 residents with 1,179 square rural miles of patrol and 4,195 square urban miles. The UTVs and trailers will be utilized for quick transportation of supplies and goods to both rural and urban areas of Pinal County.
3. The objectives and goals for the UTVs and trailers will provide the ability to access rural and urban areas of the county during community events, providing resources such as food, water, and aid to the residents and staff of Pinal County.

Documentation of the use of the UTVs and trailers will be carefully documented for use in events and the community through an internal documentation on a weekly basis and reported to the proper chain of command (Community Relations Sargent) on a monthly basis.

The goal of the Community Relations Unit needed for the UTVs and trailers is to provide an alternative means of transportation that will quickly and efficiently allow access for the unit to provide essential resources to the community of Pinal County and staff in both rural and urban areas that traditional patrol vehicles may not be able to access.

The use of the UTVs and trailers during the yearly Country Thunder Music Festival. This vehicle will allow access between crowds, small alleys, allowing closer access to PCSO staff, community members, as food, water, and other necessities are needed for the time of the event

for PCSO members providing security and the community attending the event. The UTVs and trailers would be available for the duration of the event 24/7 as the CRU staff provides services

to PCSO staff during the duration of Country Thunder (an average of five days with rotating shifts). This UTV and trailer will be utilized year round for events. The CRU has many events throughout the year that would show the relevance of the use and need for the UTV and trailer.

4. Provide a timetable for implementation of the Project: The time that the UTVs and trailers will be used is unlimited. Both resources will be utilized on a weekly basis to help support the residence of Pinal County for events and PCSO staff. These resources will be continued even after the end of the grant period.
