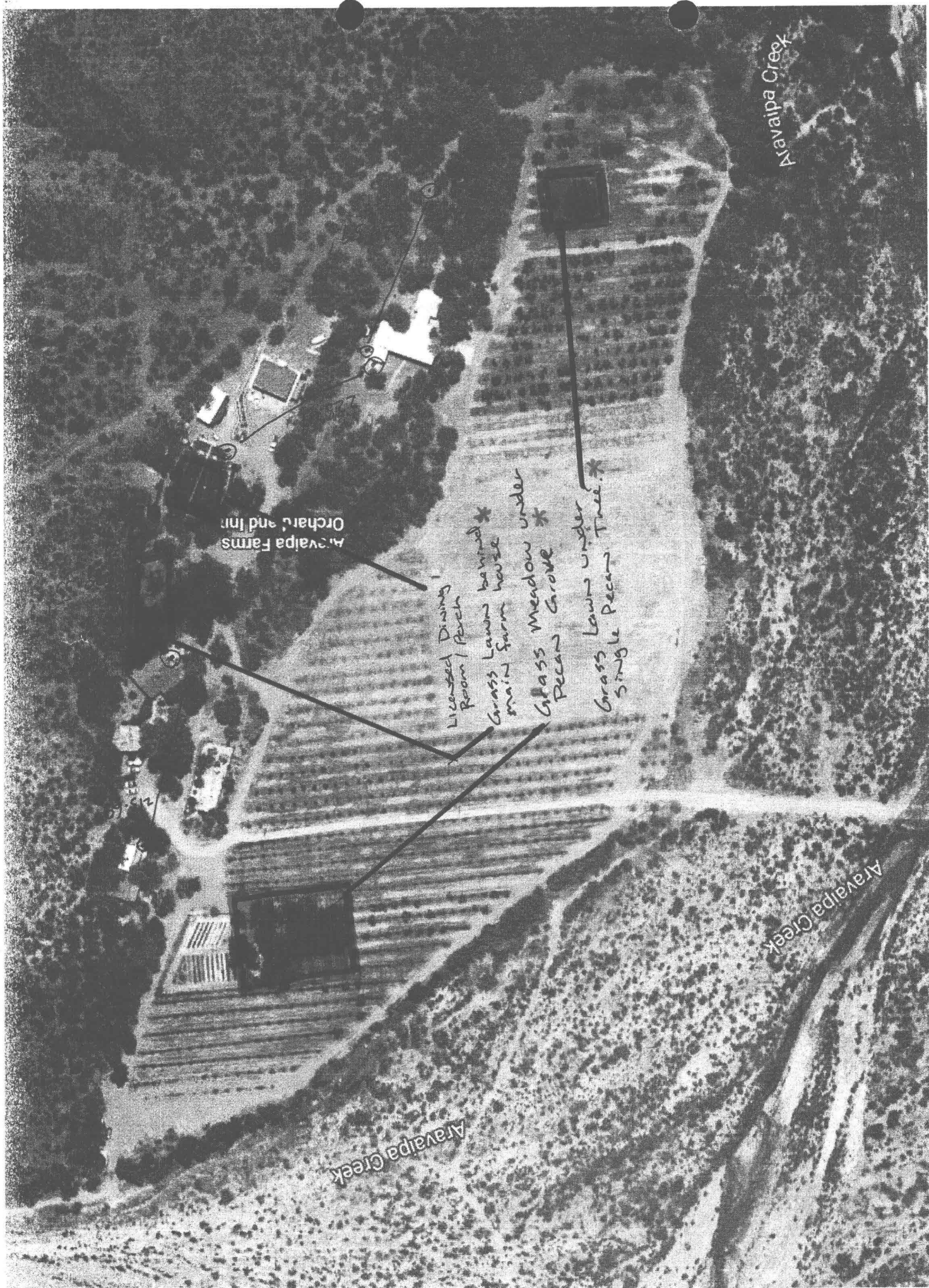

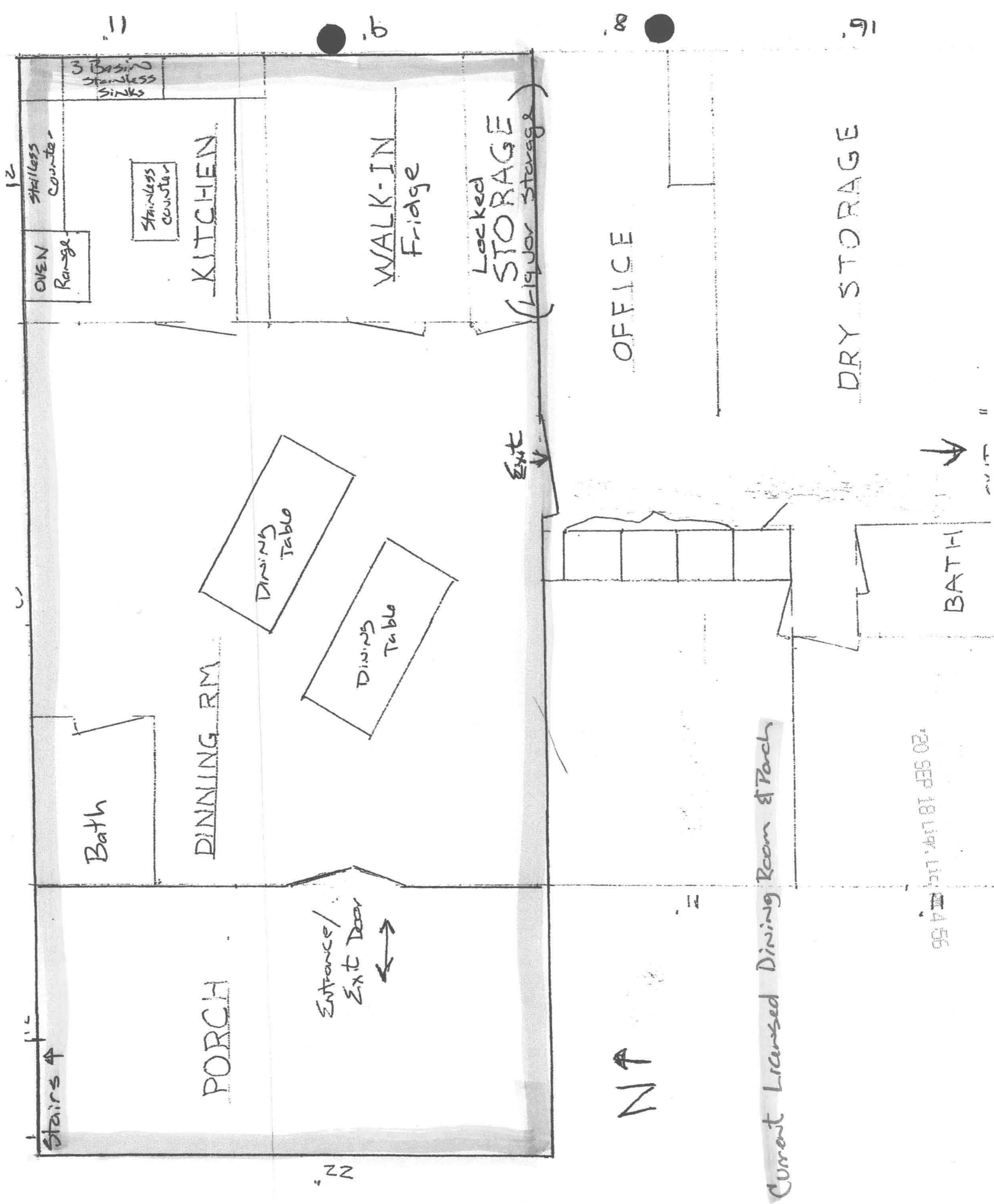


* Proposed Extended Areas
