### **History & Purpose of Grant**

Describe The VA HEALTH & WELLNESS CENTER OF AZ" Project" is registered with the AZ Corp Commission with an international 5013c Status. DBA Maricopa Veterans Care Center - 82-3338661. The core mission of the Maricopa Veterans Care Center Project is to change the way the world defines, views, and treats veterans and the general community with Post Traumatic Stress Disorder and other mental disorders so that every veteran and community member can live life to his or her fullest potential by providing free therapy, educational training, food, clothing and housing assistance with grants, local partnerships, and fundraising activities.

The (CFO), Kent O'Jon, has a Bachelor of Science degree in Social Psychology and a MBA degree in Project Management. He himself has suffered with PTSD and understands the importance of continued care. He has been purchasing, rehabbing, and renting properties for 20 plus years nationwide in the U.S and has broadened his reach internationally. Kent's love of country led him to join the Marine Corps in 1984, where he served 15 years active and as a reservist. Next, he joined the Air National Guard and served 6 and 1/2 years as a Munition Technician and Security Forces Augmentee. In 2006 he joined the Army and served 11 years as a Military Policeman. During his service he served two assignments in Iraq, one in Afghanistan and one assignment in Guantanamo Bay, Cuba. Chrystal O'Jon, VP of Operations & Marketing/Advertising has worked at a bank in the Property REO Division and as a Marketing & Promotions Director in the entertainment industry in some capacity for 20 years and will work to build a solid brand presence. Together, they have decided to take their experiences and use their skill sets to make a difference by providing FREE PTSD care and to help stop the cycle of homelessness among Military Veterans and their families and all Arizona citizens in need through therapy, job training and proving food, clothing, and housing options with local and participating partners.

### **Identified Population & Target**

The Project is established in Maricopa, AZ Pinal County where out of 60k residents exists a large population of veterans having to travel a great distance for general care. Many don't have family assistance or vehicles with which to drive to the nearest V.A. Hospital. Our organization seeks to continue and expand its reach by partnering with more local medical facilities, local therapists, clothing, food, transportation, and housing supply organizations to collect, store and distribute items all year round, as well as providing job training for employment and future stability.

Currently, the Project receives small funds and clothing from Local Companies via <u>5k races</u>, <u>Men's Wearhouse</u> and the <u>Benevity Funds</u>. With these items we provide and offer year-long free therapy for Veterans, First Responders and the public suffering with PTSD and other such similar emergencies. The Project has partnered with local Maricopa therapists but will extend that partnership to include therapists in areas outside of Maricopa/Pinal County. Because of the recent pandemic and the emotional duress, it causes the need continues to grow.

The Projects' population target includes and will extend to 1. U.S. Military Veterans and their families in the city of Maricopa/Pinal County and to include all Native American Reservations up to

40 to 50 miles outside the city of Maricopa. 2. First Responder Organizations with emergency needs 3. LGBTQ 4. Minority and other Underserved community members.

### Project Goals, Objectives, and Strategies for 12 to 24 months

The Project will start, with its current base to ascertain the benefits and determine ways in which to increase that base quarterly. The Project will Collect demographic data on the target audience via online surveys to its base and the public in general.

The Project does and will continue look for trends via state and county statistics and in online customer feedback to improve its services and knowledge base of needs. The Project, based on the community needs will assess policy, system, and environmental issues to effect community change involving laws, regulations, rules, protocols, and procedures designed to guide or influence behavior.
