Along with those items we'd like to make a free event so everyone can enjoy the history of Florence which is ranching and farming. and to be able to show them how hard our forefathers worked as ranchers and ranch hands.

Florence Junior Parada was established in 1932 by Charles Whitlow to raise milk money for the school children during the Great Depression; the rodeo grounds in Florence bear his name to this day. One of our foundation's directors, Bill Foster, is the Grandson of the late Charles Whitlow.

If awarded, the children participating in the event and the event goers of all ages will reap the benefits. The children for prizes and the event goers will gain free, unlimited access throughout the weekend to the event.


