Explain the perceived need and explain how the proposal will address that need.

Through the years, the San Tan Valley has grown with families that want to be away from the city. Mary Gloria has worked with them for several years and has seen some of the problems families face. For example: Families are living paycheck to paycheck. Families do not know of all the resources available to them. Women have low self-esteem, lack of confidence, unaware of resources, lack life skills, and limited technical skills. These efforts will assist to address them. Most recently, Mary Gloria was interviewed by Josh Ortega, Tribune Staff Writer on May 13, 2022 that was published in the Queen Creek Tribute.

Gloria started Pan de Vida Foundation because it's part of her charitable upbringing. In 2009, she began revitalizing the community by cleaning up the neighborhood of trash and drug houses, as well as paving the dusty streets and graffiti-covered buildings. Gloria has helped the people of the neighborhood of Valley of the Sun Estates, with food and other necessities and later, started the health fairs and a clinic that served Queen Creek, San Tan Valley families with the volunteer support of five physicians. The pandemic slowed her down a bit, but it also slowed down as charitable giving declined. As it picks up again, so too does the activity by Gloria and the foundation volunteers. Pan de Vida will continue to support both its programs; "Family Explorers" and the "Grupo Mujer; both learning programs. The Family Explores creates bonding and learning along with their parents, through the tours and trips to libraries, hiking, and nature trips with their children. The "Family Explores" children, have learned to value family togetherness, Friendships, and nature.

The Explorers group will meet monthly to share with other families about what programs are available to them in their own community. Now is time to reach more families in the outlying areas of San Tan Valley and Queen Creek areas.

Grupo Mujer is a women's group program that brings all kinds of topics to the community members; the group will meet two times a month in a rented or provided space where mothers will interact with one another and share in what they learn. Health: Diabetes, Heart Attacks, What Food not to eat after 50; Arts, fitness, Etc.

Describe the population who will benefit from the proposal if approved.

Pinal County has a population of 450,000. The project will focus on working with families in the towns of Queen Creek and San Tan Valley. Meetings will be held in the neighboring business and churches of the area and in Queen Creek and San Tan Valley until the center is built in San Tan Valley.

Families of the area, comprise of 87% having a high school diploma and 21% with a college education. 11% of the population lives in poverty. 31% of the population is Hispanic and 17% of other minority group that includes black or African Americans, Asians, Pacific islander, and American Indians. 21% speak a language other than English at home.

Budget narrative

Personnel

Project Director: (.25) part-time \$50 X 40 hours a month x 12 months = **\$24,000**.

Oversee all program activities, presenters and consultants report directly to her; Monitor the budget monthly with assistant and bookkeeper; Approves timesheets and invoices for payment; Serve as Coordinator, Facilitate the Family Explores and Grupo Mujer.

Assistant: (.375) part-time \$25 X 60 hours a month x 12 months = **\$18,000** Proof and edit all products, handouts, articles developed; Facilitate meetings; Prepare event packets; Prepare and conduct event satisfaction surveys; Work with Pan de Vida Webmaster to keep website up-to-date; and any other event to responsibilities like registration.

2 Facilitators: (.25) part-time \$15 X 40 hours a month x 12 months = \$7,200(2) = **\$14,400**. Assist Team with event activities, as requested.

Volunteers: \$15 X 8 hours X 10 Volunteers x 12 events = **\$14,400**. Support facilitators at Explorer events.

Operating expense

Event fees for families. 200 individual family members X \$20 X 12 events = \$48,000. Families will pay \$10 per family member and the program will pay for \$10.

Grupo Mujer meetings will meet 2 times a month. 2 meeting X 4 hours X \$100/hour X 12 months = **\$9,600**.

Office supply expense

\$3,000 for printing and copying of survey and meeting materials and **\$14,400** for refreshments and incentives for families and Grupo Mujer. \$5 per individual family member at monthly meetings (200 attendee X \$5 X 12) = \$12,000. \$100 a month for Grupo Mujer X 12 = \$1,200 and \$600 for incentives. \$600 in-kind for incentives.

Administration cost

\$1,200 for 12 months.

Dear Applicant:
