A RESOLUTION OF THE PINAL COUNTY, ARIZONA, BOARD OF SUPERVISORS APPROVING A NON-MAJOR COMPREHENSIVE PLAN AMENDMENT AND AMENDING THE COMPREHENSIVE PLAN LAND USE MAP FOR CERTAIN PROPERTIES LOCATED IN UNINCORPORATED PINAL COUNTY BY CHANGING THE LAND USE DESIGNATION FROM MODERATE LOW DENSITY RESIDENTIAL (1-3.5 DU/AC) AND HIGH INTENSITY ACTIVITY CENTER TO GREEN ENERGY PRODUCTION; IN CONNECTION WITH PINAL COUNTY COMMUNITY DEVELOPMENT DEPARTMENT CASE NO. PZ-PA-005-22

WHEREAS, the Pinal County Board of Supervisors ("Board") is authorized pursuant to Arizona Revised Statutes § 11-805 and Pinal County Development Services Code § 2.170.110 to approve Non-Major Comprehensive Plan Amendments; and

WHEREAS, on May 13, 2022, the Pinal County Community Development Department received an application for a Non-Major Comprehensive Plan Amendment from an applicant representing the owners of certain properties comprising approximately 360± acres located southeast of the central Coolidge area (Tax Parcel Nos. 202-35-0040, 202-36-003B, 202-36-003C, and 202-36-003D situated in Sections 31, 32, T5S, R09E, G&SRB&M, as legally described in the attached Exhibit A (the "Property")) to re-designate approximately 360± acres from Moderate Low Density residential and High Intensity Activity Center to Green Energy Production land use designation. (Case No. PZ-PA-005-22); and

WHEREAS, on November 17, 2022, the Pinal County Planning and Zoning Commission held a public hearing on Case No. PZ-PA-005-22, after providing notice pursuant to statutory requirements, and following the public hearing voted 0 to 8 in favor of forwarding a recommendation of denial as per staff report, to the Board; and

WHEREAS, on January 25, 2023, the Board held a public hearing on Case No. PZ-PA-005-22, after providing notice pursuant to statutory requirements, and considered the application for the Non-Major Comprehensive Plan Amendment.

NOW, THEREFORE, BE IT RESOLVED by the Pinal County Board of Supervisors that the application for the Non-Major Comprehensive Plan Amendment in Case No. PZ-PA-005-22 is hereby approved and the Comprehensive Plan Land Use Map for the Property legally described in the attached Exhibit A is hereby amended by changing the Land Use designation from Moderate Low Density Residential and High Intensity Activity Center to Green Energy Production land use designation.
