Ak-Chin Indian Community 2023 Prop 202 – 12% Contribution Grant Narrative

A. Purpose of Grant

- 1. The need for the grant is to finance our Financial Literacy, Health and Wellness, and other financially related workshops for the business members of the Black Maricopa Chamber of Commerce. There is a need due to the fact that Black Americans represent the lowest percentage of business owners in the State of Arizona (1.1%.) The grant funding will be used to rent workshop venues, provide refreshments, pay business overhead, needed literature and maintaining the BMCC website: www.blackmaricopacc.com.
- 2. The target population is the Black American Business owner population in Pinal County (specifically the City of Maricopa.) The City of Maricopa is 13% Black American. Of the estimated 9100 Black American residents, 50% of that number is being deducted (Senior Citizens, and underaged youths.) Of 4600 residents, 1.1% are estimated to be business owners. That leaves around 45-46 Black Business Owners. So the target will be 45-46 business owners who are Black American.
- 3. The objective of proposed workshops is to increase the education level of the Black business owners and thus increase business profitability and decrease unemployment, poverty, and incarceration. The Black Chamber was founded in May 2022. We sponsored a meet and greet on December 10, 2022 to introduce the Chamber to the City Of Maricopa residents. The event was held at the Luxe Lounge at the Ak Chin Theater in Maricopa.

2023- The Chamber is presently sponsoring three events.

The progress of the Chamber will be monitored by quarterly meeting minutes (available upon request.)
