Project summary: Raising Special Kids proposes to serve 100 Pinal County families who have a child with a disability or special health care need learn to navigate the complicated health care and education systems. This program builds families' capacity to understand the nature of their child's disability and enhance their skills in advocating for, and securing, educational and health services to improve their child's long-term health outcomes.

Beneficiaries: 100 unduplicated families living in Pinal County whose children have disabilities or special health care need will be served at no cost. We serve families representing all races and ethnicities and their children, ages birth to 26 years, who have a developmental disability or more substantial health care need. Approximately 30% of the families we serve live below the Federal Poverty Guidelines.

Supervisor District: Our services are provided in all five districts of Pinal County.

Raising Special Kids



A. Purpose of Grant.

1. Describe the proposed program, project or purchase (collectively, the "Project"). This description should identify the needs/issues the Project will address.

Raising Special Kids (RSK) respectfully requests a grant of \$50,000 to support services to families whose children have disabilities and special health care needs through our Navigation, Coaching Support-4-**AZ Families** program in Pinal County. Our program is client-focused, community-based and provides teaching, modeling, and training for Pinal County families and is delivered at no cost. We also connect families with community resources, providers, and services that will help improve their child's long-term health, academic success, independence, and self-sufficiency into adulthood.

The CDC reports 1 in 6 children living in the U.S. has at least one developmental disability, and 1 in 5 children has a more substantial special health care need. In Arizona, the Department of Developmental Disabilities (DDD) 2022 Family Support Annual Report shows that more than 30,000 children and adolescents (ages birth through 21 years), our target population, were eligible for services as of June 30, 2022. To be eligible for DDD services, a child must, "have at least one of four diagnoses manifested before the age of 18 that is likely to continue indefinitely." These children's families are tasked with navigating complex, bureaucratic, overlapping systems for the care of their child, which can become a barrier to accessing the services they need, all while attempting to manage the daily challenges that their child may face. Unfortunately, families have also experienced a drastic decrease in traditional supports over the past few years due to the impact the pandemic had on health and education systems.

In fact, RSK fields more than 11,000 calls each year from Arizona families looking for assistance. More than 30% of inquires come from parents seeking assistance managing their child's behaviors. RSK has also seen a 20% increase in requests since the pandemic from families seeking assistance with special education concerns for their child. Many parents come to us feeling stressed, anxious, and overwhelmed.

RSK's services are unique because they are delivered by staff members who have a personal, lived experience in common with the families we serve. Most of our staff has a child with a disability or special health care need and have years of experience navigating the systems. Our staff lend an understanding ear and assist families in identifying and locating appropriate resources.

2. Identify the target population that will be served by the Project. (Who will benefit? How many will be served? Is there a targeted geographic location? Etc.)

The population who will benefit are families that are seeking help, resources, and referrals to better understand and care for their child with a recent diagnosis, disability, behavioral challenge, and/or special health care need. Raising Special Kids (RSK) will serve 100 families throughout Pinal County who have concerns about a child, youth, or young adult living with a diagnosed or suspected disability. Children are served at all stages of development from ages birth to 26 years.



Approximately 13% of Pinal County children (under 18) live below the poverty line, according to current Census Reporter website data. The World Population website currently reports that the Pinal County child dependency ratio is approximately 40% and population by race is as follows: 76.76% White, 6.9% Two or more races, 5.1% Other race, 4.74% Native American, 4.5% African American, 1.65% Asian, and 0.35% Native Hawaiian or Pacific Islander. RSK's program will serve families from these demographics.

RSK performs community outreach and has numerous referral partners throughout Pinal County, which will help connect us to families in need of our program.

3. Describe the Project goals and objectives and outline a plan to meet these goals.

RSK's Navigation, Coaching Support-4-AZ Families program goals include serving 100 Pinal County families to increase their knowledge to make informed decisions for their child's care and build skills to work with providers and educators to secure services that meet the unique needs of their child. Our long-term objective is for families to become effective advocates and secure care and services for their children to grow to reach their highest potential.

Our short-term goals are that through the program, 100 Pinal County families will:

- 1. Learn how to navigate the health care system currently operating under Medicaid flexibilities to address the specific needs of their child.
- 2. Increase health literacy (learning about and processing health information and specific diagnoses) to make well-informed decisions about their child's complex health and/or behavioral needs.

Our medium-term objectives are that families will experience an increased quality of life, as evidenced through pre- and post- session/course survey data. Families will report 85%, or above, agreement on the following survey items:

- I feel prepared to use the knowledge I gained.
- The support I received was useful in helping me address a problem or issue I am having.
- I found the information and materials high quality.
- I would recommend RSK to a friend or family member.

Our plan to meet these goals follow established, best practice program activities including:

- Strategic outreach to Pinal County families to increase awareness/understanding of our services.
- Individual 1:1 direct assistance to parents and families.
- Individualized problem solving.
- Education on rights and responsibilities under federal entitlement programs.

RSK focuses on health care, training, and education to help families achieve their goals and move forward. RSK would like to continue to grow and expand our staff capacity to reach more families in need throughout Arizona, including Pinal County.

4. Provide a timetable for implementation of the Project.

The Navigation, Coaching Support-4-AZ Families activities are on-going throughout the 1-year grant period. Families can access our services at any time during this term.

B. Resources.



1. Identify current funding sources for the Project and characterize each funding source listed as either a one-time-only or long-term funding source.

RSK is seeking one-year funding for this Pinal County-based program from Pinal County Board of Supervisors, which is a one-time funding source. Other funding sources for our program in Pinal County include insurance reimbursements for qualifying services, which is a long-term source of funding but only covers partial services for families. We also supplement funding with individual donations, which is typically a one-time funding source.

2. Identify other organizations or partners that are participating in or contributing to the Project, but which are not funding sources, and describe their roles or contributions.

RSK has established long-standing relationships with school districts in Pinal County, Head Start programs, and local therapy providers. These relationships will be leveraged to promote the program and identify parents and families that need, would benefit from, and want to participate in the program. Partner agencies include: the Arizona Department of Economic Security, Division of Developmental Disabilities, Arizona's Early Intervention Program, the Rehabilitation Services Administration/Vocational Rehabilitation, Arizona Department of Health Services, the Arizona Department of Education, Arizona's Medicaid program (AHCCCS), and many more. These entities currently support projects or collaborative activities with RSK and comprise a statewide referral network of over 300 organizations.

3. Define the Project as a new or continuing project or a purchase. Provide information about how the Project will be sustained or the purchase will be maintained after the grant funding is exhausted.

This is a continuing program. RSK has many sources of diverse agency revenue that contributes to our programming and sustainability. These sources include tax credit donations, special events, government contracts, and foundation and corporate grants. We also bill insurance for select services, which adds an additional, consistent source of revenue.

Pending requests to other tribal governments include: Gila River Indian Community – Positive Parenting education and navigating education and health care systems for families of children with disabilities and special health care needs in Maricopa County. Fort McDowell Yavapai Nation – Navigating education and health care systems for families of children with disabilities and special health care needs in the City of Phoenix.

Funded requests: Ak-Chin Indian Community – Navigating education and health care systems in 20/21 (\$20,000), in 21/22 (\$50,000), and in 22/23 (\$50,000); Fort McDowell Indian Community – Positive behavior parent support in 2021 (\$7,000) and in 21/22 (\$15,000).

RSK has successfully managed multi-million-dollar state and federal contracts and grant awards for several decades. We have also successfully managed corporate and foundation grants. RSK is an excellent steward of all grant awards and has the staff capacity to manage them.

RSK staff keeps records from intake to case closure for each family receiving services. Staff collect preand post-survey data to evaluate and share with key stakeholders. All documentation is stored in a secure online database.

RSK has always provided timely reports of our activities and management of funds granted to us from the Ak-Chin Indian Community.

RSK would like to provide more information to the Ak-Chin Council about steps we take to improve equity in our services as a result of our own internal evaluations. Improving equity begins with our leadership through evaluation of our programs, outcomes, and employment practices. We foster a culture of inclusion and seek to respond to the needs of our clients, even as they change. Further, when inequities are identified at service completion by direct feedback or through staff observation, RSK program staff and leadership discuss these concerns at their regular meetings. As with many organizations, RSK is taking steps such as modifying language in surveys to be more inclusive as our community changes. We also emphasize recruitment practices that bring diversity to our organization.

Our Board of Directors is responsible for ensuring that the needs and perspectives of families and children with the full range of disabilities, from birth to age 26, are represented and remain the consistent



focus of the project. The Board meets six times a year to review activities of the organization. They nominate, interview, and approve all new Board members. The Nominating Committee supports the Board's efforts in identifying and recruiting candidates who fill the critical gaps in representation of skills and diversity. Our hiring process follows the same standards, and RSK seeks to hire staff representative of the community we serve.
