Ak-Chin Indian Community 2023 Prop 202 – 12% Contribution Grant Application

A. Purpose of Grant.

1. Describe the proposed program, project or purchase (collectively, the "Project").

The Oracle Piano Society has served Oracle and its surrounding rural communities for eleven years as a performing arts/education nonprofit that owns and operates the Oracle Center for the Arts. In 2020, during the pandemic, we created an online Conservatory program to serve local, at-risk youth with weekly violin, viola, cello, and piano lessons taught by accomplished members of the Oracle Piano Quartet. The program was created using funds from our Chamber Music Festival budget, which was unable to safely operate during the pandemic. Now, that we are fully opened, we have brought back the Chamber Music Festival and seek to expand our Conservatory to serve as more students in need.

In addition to the weekly lessons they will receive during the academic year, they will also attend our annual chamber music festival and our Signature Series concerts, where they will meet face-to-face with the celebrated guest artists and, when possible, join them for master classes. Additionally, those students will gain valuable insight into nonprofit leadership by serving as apprentices to the Artistic Director. This means that they will have the opportunity to give back to their community by helping out with the festival and concert logistics. Not only will this help our students develop a sense of responsibility and ownership, it will also enable them to further immerse themselves in the world of music.

We believe that the impact of this program, when fully realized, will rival any youth music education and performance program that is currently available in this country or worldwide.

We are passionate about providing barrier-free music education for at-risk youth in our community. Funding from the Ak-Chin Indian Community would be the pivotal component needed to launch this program to its fullest potential.

2. Identify the target population that will be served by the Project. (Who will benefit? How many will be served? Is there a targeted geographic location? Etc.)

Oracle Piano Society is located in the rural community of Oracle, Arizona. In addition to directly providing concerts and educational programming for the residents of Oracle, we have targeted San Manuel, Mammoth, and the San Carlos Apache Reservation as other areas to support. Additionally, we serve the larger metropolitan areas of Tucson, Oro Valley, and Greater Phoenix. Our Conservatory program consists of local, low income k-12 rural, at-risk students who would not normally have access to high level music instruction. Our Chamber Music Festival serves those enrolled in our Conservatory program but also includes collegiate students from ASU, U of A, Concordia College, BYU, UNLV, etc. Additionally, there is an adult amateur component of the Chamber Music Festival which provides music education for lifelong learners. All of our performance and education events are open to the public and we have a large group of loyal audience members. Attendance at our concerts averages 70 to 80 audience members with 55 of those being Season Ticket holders.

Our Chamber Music Festival student enrollees average 32 each year and we have set a target number of 20 students for enrollment in our Conservatory.

3. Describe the Project goals and objectives and outline a plan to meet these goals.

Access to high-qulaity music education is out of reach for at-risk, low-income students living in rural Oracle and the surrounding rural communities of San Manuel, Mammoth, and the San Carlos Apache Reservation. Our goal is to solve this problem by creating world-class educational opportunities for those students.

We have currently set a goal to enroll 20 students for the 2023 - 2024 Academic year. In order to recruit students, we have reached out to the San Carlos Apache Indian Reservation School District, the Oracle School District, and created a list of local students who expressed a need for music education.

We are also in the process of expanding our faculty. Our 2023 - 2024 faculty will include Dr. Luciana Gallo, cello; Dr. Gregory Hamilton, piano; Dr. Sarah Schreffler, violin; Prof. Monte Belknap, BYU Violin, Dr. Stephen Cook, piano; Dr. Christopher Norby, composition; Dr. Allyson Wuenschel, viola; Prof. Kate Hamilton, UNLV viola; Jeffrey Weisner, bassist for National Symphony Orchestra; Dr. Fanya Lin, U of A Professor of Piano, and R. Carlos Nakai, guest clinician.

We have also begun several fundraising campaigns to ensure that our project is successful.

4. Provide a timetable for implementation of the Project.

Created in 2020, the Conservatory project takes place every academic year from September to May. Lessons are taught weekly throughout that period. Students also attend and volunteer at our Signature Series concerts which happen about once per month on Sundays during the September to May season. Additionally, students will attend the Chamber Music Festival which is a five-day intensive program featuring daily lessons, classes, and performances. This year's Chamber Music Festival will take place January 2-7, 2024. The number of students enrolled is directly related to the amount of financial support we receive.

B. Resources.

1. Identify current funding sources for the Project and characterize each funding source listed as either a one-time-only or long-term funding source.

This year, we have received enough earmarked donations from the community to enroll three students in our Conservatory program for the entire academic year. We have currently launched a campaign to raise additional funds to support more students. Our target number of students for this year is 20. In addition to donations, we receive revenue from Signature Series concert tickets and Season Tickets. We receive annual funding from the Lynne Cooper Harvey Foundation, and the Arizona Commission on the Arts has awarded us Festival Grants since 2019 and a Lifelong Learning Grant in 2023 for our Chamber Festival. Additionally, we have received funding for capital improvements from the Pinal County Board of Supervisors. We have submitted applications for additional funding from the Gila River Indian Community to support

our Chamber Music Festival, to the Arizona Commission on the Arts Creative Capacity Grant to support general operating expenses, and have partnered with Cuba Rhythm and Views to organize a cultural excursion to Cuba to support education.

The Conservatory is a continuing project. The project will be maintained through vigorous fundraising campaigns, grant applications, revenue from ticket sales, and individual sponsorships. This is the central program of Oracle Piano Society and, as such, is considered a top priority when making budgeting decisions.

Oracle Piano Society has submitted an application to the Gila Riva Indian Community to fund the 2024 Oracle Chamber Music Festival, which is a component of our Conservatory. Here is the summary of the project that was submitted:

"Every January, elite artist faculty descend upon the beautiful rural town of Oracle to create a vibrant cultural event. Students ranging from youth, collegiate, and adult-amateur participate in thrilling live performances and illuminating classes and discussions. These students experience an inclusive curriculum involving daily lessons, master classes, and seminars. The program serves the local community of Oracle and also attracts talent from across the country.

In 2023, because of an outpouring of community support, we were able to provide full scholarships for all youth and collegiate students who requested aid. Those students receiving aid provided volunteer support for the festival as teacher's aids, stage hands, meal prep, etc.

Our ten-member faculty includes two cello instructors; Dr. Luciana Gallo, University of Nevada at Reno & Dr. Gregory Hamilton, Concordia College; two piano instructors; Dr. Stephen Cook, Artistic Director, Oracle Piano Society & Dr."

We will be notified of our award status in August of 2023.

We are awaitng a decision on our 2023 application to the GRIC Grant to fund the Chamber Music Festival. That was our first application for tribal support.

Funding for the Conservatory will be tracked in the budget based on the number of students enrolled and expenses related to each student's participation in the program. Faculty members will be paid a competitive rate per student served.

Our success is measured by students enrolled, effectiveness of programming, and progress of students. When fully funded, we will provide free lessons for the entire 2023-2024 academic year for 20 local at-risk students in rural areas. Funding will also enable us to enroll 32 students in our 2024 Chamber Music Festival, which will take place in January.

Student performance in semester-end recitals and juries will be evaluated by our highly-qualified faculty members, who are experienced performers and educators.
