- \* A. Discussion/approval/disapproval of Minutes from April 3, 2024, Board of Directors Public Health Services District Meeting. (Natasha Kennedy)
- \* B. Discussion/approval/disapproval of Amendment No. 6 of the Intergovernmental Agreement (IGA), Contract No. YH16-0018-09 between the Arizona Health Care Cost Containment System (AHCCCS) and Pinal County. This amendment changes the rates referenced in the IGA and the quarterly estimated State match advance payment. The IGA established procedures to permit AHCCCS to pay for medical services that qualify for Federal Financial Participation provided to the inmates of the Pinal County Jail Detention facilities. (Kore Redden/Merissa Mendoza)
- \* C. Discussion/approval/disapproval of the Award Agreement under the Sexually Transmitted Infection (STI) Screening Program between Arizona Family Health Partnership, hereby referred to as Affirm Sexual and Reproductive Health, and Pinal County through the Pinal County Board of Supervisors beginning January 1, 2024, ending December 31, 2024, for a total maximum of \$33,000. This grant will be used by Public Health to provide STI testing and treatment to sexually active female clients 24 years of age and younger as well as gonorrhea and syphilis testing to sexually active male and female clients 34 years of age and younger under the Family Planning Program. A pro-rated amount was adopted in the FY23/24 budget. The remaining amount will be budgeted in FY 24/25. There is no impact on the General Fund. (Carey Lennon/Merissa Mendoza)

Discussion/approval/disapproval of Intergovernmental Agreement Contract No. CTR057224 Amendment No. 3, for the COVID-19 ELC Enhancing Detection Expansion project between the Arizona Department of Health Services and the Pinal County Public Health Services District through the Pinal County Board of Supervisors. This amendment extends the term of the agreement to end July 31, 2026. This agreement was originally approved December 15, 2021, all terms of the original agreement remain in effect with this extension. (Kore Redden/Merissa Mendoza)
  
- \* B. Discussion/approval/disapproval of a Contract award under the Family Planning Program between Affirm Sexual and Reproductive Health, and the Pinal County Public Health Services District, through the Pinal County Board of Supervisors, beginning April 1, 2024, ending March 31, 2025, for an amount not to exceed \$350,000. This grant will be used by the Public Health Department for family planning services. Acceptance requires an amendment to the FY 23/24 budget to transfer appropriation between Fund 213 (Grants/Project Contingency) and Fund 82 (Health/Grants) to increase revenues and expenditures. Medical/Forensic Interview Peer Review

Current CAC Response:

The Pinal County Family Advocacy Centers (FAC) have four physical locations in Pinal County. One resides in rural Eloy Arizona, another in suburban Maricopa a third in suburban San Tan Valley, and a satellite resides in rural Oracle, Arizona. The lead applicant will be the Eloy Family Advocacy Center in Eloy. Two of the three centers are accredited by the National Children’s Alliance (NCA) , with the third having just completed a successful site review for first time accreditation. The Family Advocacy Center (FAC) multi-disciplinary teams (MDTs) serve community members in the third largest geographical county in Arizona. The three FACs serve 13 different law enforcement agencies including three Tribal jurisdictions. Our centers have an MOU



with the Federal Bureau of Investigations offering the use of the advocacy centers in federal matters. Pinal County's Family Advocacy centers currently serve all child victims of physical abuse, sexual abuse, neglect, trafficking and witnesses to violence such as domestic violence and homicide. Available services include forensic interviews, forensic medical examinations, victim advocacy and mental health treatment. Victim advocates provide crisis response, education, victims' rights information, victim compensation assistance and referrals to all manner of social services after assessing for needs. Some of those referrals might include financial assistance, housing or shelter, mental health services, crime scene cleanup, food assistance, assistance with orders or protection and referrals for other legal needs. Referrals are received from law enforcement and child services and any case within the county can be seen at any center and/or the center most convenient for the victim.

#### Need Statement:

Pinal County is in need of an updated, HIPAA compliant interview storage system that will help facilitate ease of case reviews and peer review on a virtual, in person or hybrid platform. The FAC currently utilizes DVDs to burn and store forensic interviews. The detectives are also provided with burned DVDs of the interviews at the completion of each case. This is an outdated form of interview storage. DVDs are unencrypted and can be easily lost, stolen, intentionally or maliciously copied or mishandled and degrade over time. Any of these outcomes could severely impact the ability of child victims and their loved ones to seek the justice, hope and healing they deserve. In addition, it has proven impossible to utilize a disc recording of an interview for case review or peer review purposes on a virtual platform.

Historically, our centers have used DVDs because no solution existed to securely share, manage and store forensic interviews with all of the added features cloud technology can provide, such as multifactor authentication and digital rights management. Our goal is to have the most secure, efficient collaboration platform to protect 100% of child forensic interviews in the cloud, to keep our operations moving forward with remote technology, to enhance our ability to quickly share critical, sensitive information with our multidisciplinary partners, and to enhance our ability to provide peer review across our four locations, while reducing operating costs and staff hours dedicated to unnecessary manual processes. With the time and cost savings, the FAC will be able to conduct more effective peer review, thereby improving the quality of interviews conducted on children.

The Eloy Family Advocacy sits in one area of a geographically large county, covering 5,366.7 square miles of land area. Pinal County's forensic interviewers are spread between three locations, each an hour or more drive away from the other. For this reason, it is vital that interviewers have a HIPAA compliant, secure method of sharing and viewing each other's interviews to conduct regular peer review. The current method of utilizing physical DVDs makes virtual peer review impossible. To this end, the FAC seeks the current grant funding to address this concern and facilitate timely, efficient and thorough peer review. The Eloy Family Advocacy Center seeks to purchase Guardify to address these pressing issues. Guardify, a division of VidaNyx, Inc., is a cloud-based digital evidence management solution that supports remote collaboration to securely share, manage and store child forensic interview videos and supporting evidence enabling continuity of case management and faster access to forensic interviews to accelerate the pursuit of justice and healing. Guardify was building collaboration with the National Children's Alliance and an advisory council of expert attorneys, forensic interviewers, prosecutors, therapists and Child Advocacy Centers across the United States.

Guardify includes 13+ layers of cutting-edge cybersecurity to protect against unauthorized access. This is the same security schema used by financial institutions, military applications, and Fortune 500 companies. Upon award notification, finance staff will complete the necessary steps to create a cost center for grant funds as well as a Purchase Order to complete the purchase. Public Health staff and the FAC Division Manager will put the acceptance of the grant on the soonest Board of Supervisors' meeting agendas following notification. Guardify will be notified of the award and initiate documents for signature. Implementation will begin immediately upon payment.

Anticipated caseload/Number of children served:

The Pinal County Family Advocacy Centers conduct between 600-700 forensic interviews each year. Taking an average of the past five years results in a yearly projected caseload of 679.


