Chairman Miller offered for the Invocation by Pastor Jerry Storrs, Sonland Lutheran Church, Casa Grande and the pledge of allegiance by Vice-Chairman McClure.

The Pinal County Board of Supervisors convened at 9:31 a.m. this date. The meeting was called to order by Chairman Miller.

Chairman Miller advised he will allow for public comments on this item and requested public comment be concise, limited to two minutes, and focused on whether to cancel the draft Development Services Code Update. As a reminder he explained the importance of following public comment guidelines and the legal restrictions on Board response, and advised a copy was provided in each chair.

Chairman Miller acknowledged the public's concerns and emphasized the need for better communication and transparency, and recommended everyone read the current code.

Supervisor Serdy spoke regarding the importance of public input and representing people who live rural lifestyles, and suggested forming panels to gather input to ensure that new regulations are better than the current draft and noted Dark Sky is not addressed either.

Supervisor Vitiello thanked the public for coming out and encouraged constituents to reach out to him.

Supervisor McClure advised he will be holding quarterly meetings with the Planning and Zoning Commissioners and increasing public involvement.

Supervisor Goodman emphasized the importance of representing all residents and ensuring that new regulations are fair and effective, by holding focus groups by zone.

Chairman Miller confirmed Staff understands the direction provided, small groups and build from the bottom up.


